Summary Proceedings of the Annual General Meeting of the Company

The 12th Annual General Meeting ("AGM") of the Members of the Company was held on Saturday, the September 28th, 2019 at 12:00 P.M. at Daffodils 23, Royal Complex, Shop 1-4, Eksar Rd, Borivali West, Mumbai, Maharashtra-400092 and concluded on 3.30 P.M.

Total 32 members attended the Meeting. Four of our Directors of the Company were present at the Meeting, including the Chairman of Audit Committee, Nomination, Remuneration & Compensation Committee and Stakeholder's Relationship Committee were present at the Meeting. The representatives of Statutory Auditors and Secretarial Auditor were also present at the Meeting.

Mr. Akshay Kumar Gurnani, Chairman of Board of Directors took the chair and welcomed the members to the Annual General Meeting. Mr. Govind Ram Thawani, Director of the Company, chaired the proceedings in respect of the items of business where Mr. Akshay Kumar Gurnani was deemed to be interested. The requisite quorum being present, the Chairman called the meeting to order.

The Chairman gave an overview of the financial performance of the Company for the financial year ended on March 31st, 2019 and given Chairman's speech together with discussing future outlook of the Company. With the permission of the Members, the Notice of the AGM was taken as read.
