बाजूला ठेवल्या तरीसुद्धा या अठराही अध्यौयांमध्ये येणारे तात्त्विक चिंतन अधिक महत्त्वाचे ठरते. अगदी दुसऱ्या अध्यायाच्या शेवटापर्यंत तू युद्ध करणे कसे गरजेचे आहे हे कृष्ण सांगत असतो. आणि अर्जुनाच्या मनामध्ये निर्माण झालेला गोंधळ. दुःख,, मोह आणि या सर्वांविषयीचा विषाद किंवा खंत गीतेच्या पहिल्याच अध्यायातून व्यक्त होऊन जाते. परंतु पुढच्या सगळ्या अध्यायांमध्ये कुठेही युद्धाचा फारसा उल्लेख नाही. ज्ञानयोग, सांख्ययोग, भक्तीयोग, ज्ञानकर्मसन्यास योग अशा वेगवेगळ्या चिंतनामधून एकूण या ब्रह्मांडाचे सार भगवंतानी गीतेत सांगितले. विभूती योगामध्ये श्रीकृष्णाने आपल्या दिव्य, भव्य विराट असे विश्वरूप दर्शन अर्जुनाला घडवले आणि मग सर्वांचा कर्ताकरविता मी आहे आणि मला तू शरण आला तर तू खऱ्या अर्थाने सूखी आनंदी, समाधानी होशील. किंबह्ना मला शरण येण्यातच तुझे कल्याण आहे. तुझ्याकडून काय करवून घ्यायचे आणि काय नाही हेदेखील मीच ठरवणार असल्याने तू फक्त तुझ्या समोर येणाऱ्या कर्माचे प्रामाणिकपणे पालन कर. ते तू जितक्या चांगल्या पद्धतीने करशील त्यातूनच तुला कर्म करूनही अलिप्त राहिल्याची खूप मोठी मनःशांती मिळेल. संपूर्ण भगवद्गीतेचे सार लक्षात घेतले तर भगवंताला साक्षी ठेवन भगवंताला आवडणारे काम प्रामाणिकपणे भगवंताला समर्पित करायचे. ते केल्याचा अभिमानही बाळगायचा नाही. आणि अशा कृतीतून आपल्याच जीवनाची धन्यता अनुभवायची ही गीतेची शिकवण आहे.

युद्ध, संसार, प्रपंच, नोकरी व्यवसाय यामध्ये येणाऱ्या अतिशय तात्कालिक क्षणभंगूर समस्यांच्या पूर्ततेसाठी भगवद्गीता नाही. म्हणजे अशा सर्व भोगलालसा उपभोगत असताना त्या नगण्य स्वरूपाच्या आहेत त्यात अडकून न पडता जीवनाची खरी उपयुक्तता काय, मिळालेल्या मनुष्यजन्माची धन्यता कशात आहे हे अतिशय आत्मविश्वासपूर्वक सांगणारा आणि जिज्ञासांची पूर्तता करीत भगवदुप्राप्तीची पिपासा जागवणारा हा ग्रंथ म्हणता येईल. म्हणूनच अगदी भगवद्गीतेच्या सुरूवातीला युद्ध न करण्याच्या मनस्थितीत असलेला अर्जुन जगण्याचे हे तत्त्वज्ञान प्राप्तझाल्यानंतर आता तू सांगशील ते मी करेन.असे म्हणू लागतो. म्हणजेच करिष्ये वचनम् तव असे शेवटच्या अध्यायात सांगून पूर्णपणे भगवंतमय होऊन जाण्याचे भाग्य अर्जुनाला प्राप्त होते. भगवद्गीतेमध्ये अनन्याश्चितयन्तोमाम् ये जना पर्युपासते। तेषां नित्याभियुक्तानां योगक्षेमं वहाम्यहं। म्हणजेच मला शरण येणाऱ्यांच्या योगक्षेमाची व्यवस्था मी पाहातो इतके ठोस आश्वासन भगवंतानी दिलेले आहे. आपल्याला मिळालेला हा जीवनयोग क्षेम म्हणजेच कुशल चांगल्या पद्धतीने पूर्ण करण्याची भगवद्गीतेतून दिलेली हमी हेच गीतेतले जीवनाचे तत्त्वज्ञान आहे. या मूलभूत गोष्टी जरी समजून घेतल्या तर रोज गीता का वाचायची. कारण ती अशाच आपल्याला मिळालेला जीवनयोग आचरणात आणण्याची शिकवण देते. भगवंतांनी दिलेले हे आयुष्य त्याने नेमून दिलेल्या कर्माचे पालन करता करता त्याला समर्पित करण्याची भव्यता गीतेतून अनुभवता येते.
