PROCEEDINGS /OUTCOME OF THE 49TH ANNUAL GENERAL MEETING HELD THROUGH VIDEO CONFERENCE/OTHER AUDIO VISUAL MODE

The 49th Annual General Meeting of the Company was held through Video Conference /Other Audio Visual Mode on Thursday, 29th September, 2022 which commenced at 02.00 p.m. IST.

The proceedings of the meeting are as under:

17 of shareholders attended the Meeting through Video Conference / Other Audio Visual Mode to form the quorum.

Mr. Rikeen Dalal, Chairman welcomed and thanked the shareholders for sparing the time to join the 49th AGM and for their continued faith in P H Capital Limited. He informed the members that the Company had taken all efforts to enable its shareholders to participate through VC and vote at the AGM in a seamless manner.

Before starting the meeting, he introduced the members of the Board and Key Managerial Persons, Secretarial Auditors and Statutory Auditors of the Company, joining the meeting from various locations one by one.
