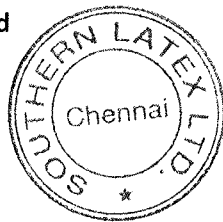

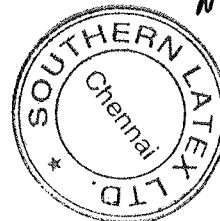

Limited Review Report

We have reviewed the accompanying statement of unaudited financial results of **Southern Latex Limited** for the third quarter ended 31st December, 2022 being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016.

Attention is drawn to the fact that the Ind AS complaint figures, for the corresponding Quarter and Half Year ended 30th September, 2022, previous year ended 31st March, 2022 as reported in these financial results and approved by the Company's Board of Directors, have not been subjected to review.

This statement is the responsibility of the Company's Management and has been approved by the Board of Directors of the company in their meeting held on 25.01.2023. Our responsibility is to issue a report on these financial statements based on our review.

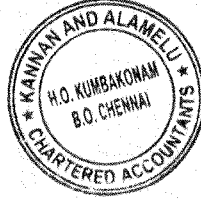
