DABHOLKAR MURDER CASE Court nod to frame murder, terror charges against four accused

A SPECIAL court in Pune on Tuesday passed an order to frame charges against the five accused in the 2013 murder case of anti-superstition activist Dr Narendra Dabholkar.

The Central Bureau of Investigation, which took over the case from Pune City police in 2014, has till now charged five accused in the case.

While Bhawe was present in the court on Tuesday, Punalekar, who is out on bail, and Tawade and Andure, who are in prison, attended via video-conferencing.
