# EC's mega electors verification programme launches today

Voters to get user name, password, upload all documents related to electoral registration and tag similar details about family members

PRESS TRUST OF INDIA New Delhi, August 31

THE ELECTION COMMISSION'S new mega Electors Verification Programme (EVP), which seeks to update electoral rolls through crowd sourcing, is set to be launched on September 1 across the country, officials said on Saturday.

Under the programme, a voter from each family will get a user name and password, allowing a person to upload all documents related to electoral registration and tag similar details about his or her family members, Delhi chief electoral

officer (CEO) Ranbir Singh said. "These details will then be

## Google to pay \$150-200m over YouTube privacy claims

PRESS TRUST OF INDIA Washington, August 31

**GOOGLE WILL PAY** \$150-200 million to settle allegations about YouTube violating a children's privacy law while gathering data to better target its adverts, US media reports said on Friday.

The US Federal Trade Commission agreed on the amount of the settlement against YouTube parent Google, which if approved by the Justice Department would be the largest settlement in a case involving children's privacy, *The New York* Times reported.

The allegations against YouTube were made by privacy groups who said the platform had violated laws protecting children's privacy by gathering data on users under the age of 13 without obtaining permission from parents, *Politico* reported.

The FTC is expected to announce its decision on the settlement in September, the New York Times said. US regulators have long argued Google fails to protect children from harmful upload and ₹1 for submitting content and data collection on its YouTube platform.

Advocacy group The Center for Digital Democracy said in a statement that the proposed settlement would be "woefully low" given Google's size and revenue, and called on the FTC to "enjoin Google from committing further violations" of children's privacy law.

Google remains the money-making engine for parent company Alphabet, with most of its revenue coming from digital ads, which accounted for \$116 billion of the \$136 billion the Silicon Valleybased company took in last year.

In January, France's CNIL data watchdog slapped Google with a record 50-million-euro fine for failing to meet the EU's tough General Data Protection Regulation (GDPR), which came into force early last year.

PRESIDENT DONALD TRUMP'S latest round of tariffs on Chinese imports is likely to deliver a direct hit on many consumers, who were largely spared from higher prices in his previous rounds of import taxes. From Sunday, the US government will begin collecting 15% tariffs on \$112 billion in Chinese imports, items ranging from smartwatches and TVs to shoes, diapers, sporting goods and meat and dairy products. For the first time since Trump launched his trade war, American households face price increases because many US companies say they'll be forced to pass on to customers the higher prices they'll pay on Chinese imports.

For more than a year, the world's two largest economies have been locked in a highstakes duel marked by Trump's escalating import taxes on Chinese goods and Beijing's retaliatory tariffs. The two sides have held periodic talks that seem

have met little progress despite glimmers of potential breakthroughs.

All the while, they've imposed tariffs on billions of each other's products in a rift over what analysts say is Beijing's predatory tactics in its drive to become the supreme hightech superpower.
