## Internet in Kashmir

Mobile telephony services and fixed line Internet across all telecom service providers were restored in Kashmir valley on Friday night as the situation remained peaceful and under control, officials said.

Voice calling on mobile phones was restored on Friday night, the officials said.

They said fixed line Internet services across all telecom service providers were also restored. Internet was earlier working only on BSNL's broadband and fibre lines. The officials said mobile Internet services would be restored on Sunday afternoon.

Mobile services, except on BSNL's postpaid, were snapped across the valley on Wednesday night as a precautionary measure in the wake of death of

hardline separatist leader Syed Ali Shah Geelani.

Mobile Internet and Internet on fixed lines, except for BSNL's broadband and Bharat Fiber were also barred.

Earlier, the decision to restore the services was announced by Inspector General of Police (Kashmir) Vijay Kumar.

"So far, situation remained peaceful and under control. Thanks for public's cooperation in maintaining law and order. Mobile service (voice call) and broadband of all TSPs shall open from today evening at 10 pm," the IGP said in a tweet on Kashmir Zone Police's handle.

Then, in a statement, the police said the situation across the Kashmir valley remained peaceful and no untoward incident was

reported from anywhere.

The IGP Kashmir thanked the people for their cooperation with police and security personnel deployed on the ground and in maintaining the law and order.

A police spokesman said in view of the peaceful situation, voice calling on mobile phones and broadband of all service providers shall open on Friday night at 10 pm.

However, Internet mobile services shall remain shutdown till Sunday afternoon, the spokesman said.

He requested the people not to pay any heed to rumours being spread maliciously by anti-national elements, especially across the border, with an objective to disturb the prevalent peaceful atmosphere in the valley.

Zagreb, Sept 4:

External Affairs Minister S Jaishankar on Friday said that India and Croatia shared a lot of common positions on issues like the Indo-Pacific, situation in Afghanistan and the two countries' resolve

to fight terrorism in all its forms and manifestations.

Jaishankar was speaking at a joint press conference along with his Croatian counterpart Gordan Grlic Radman here.

"On international

issues we shared a lot of common positions and perspectives. It was very apparent in our discussions on Indo-Pacific, on Afghanistan, on our resolve how to counter terrorism in all its forms and manifestations," he said.

Stressing on increasing economic cooperation between the two countries, Jaishankar said that there are a lot of opportunities in pharmaceuticals, digital and infrastructure sectors.

"We believe that Indian companies will find Croatia a very good platform to operate and invest," he said.

Jaishankar said "there are already companies from Croatia operating in India and some of them have secured some important contracts like in the railway sector. We would certainly welcome more active efforts to cooperate in the defence sector."

"Tourism is another very important area and we were talking about expanding air connectivity between the two countries," he said.

Earlier during their meeting, the two leaders discussed several topics of mutual interest, including EU-India relations, situation in

Afghanistan, economic and cultural cooperation and post-COVID recovery.

"I very much value the perspectives that I heard from the Croatian side about the EU, about the further prospects of the EU, about your own region. I think it is very helpful for us to get a better understanding of what is happening," he said at the press meet.

Jaishankar was received by Croatian Prime Minister Andrej Plenkovic. He arrived here after completing his two-day visit to Slovenia, during which he held bilateral meetings with his Slovenian counterpart Anze Logar, apart from calling on the country's top leadership.

During his meeting with Plenkovic, Jaishankar discussed opportunities to further expand bilateral cooperation, including in pharma, digital and infrastructure.

## Modi discusses regional issues with Abu Dhabi prince

New Delhi, Sept 4:

Prime Minister Narendra Modi and Crown Prince of Abu Dhabi Sheikh Mohamed bin Zayed Al Nahyan on Friday discussed regional developments and agreed that there is no place for terrorism and extremism in the world, while stressing on the importance of the international community standing together against such forces.

Their discussion comes amid the developments in Afghanistan, with the Taliban taking over the country and America

withdrawing its troops.

During their telephonic conversation, the two leaders positively assessed the continued progress in bilateral cooperation in various areas under the India-UAE comprehensive strategic partnership, a Prime Minister's Office (PMO) statement said.

Prime Minister Modi appreciated the UAE's support for the Indian community during the COVID-19 pandemic, and also conveyed best wishes for Expo-2020 to be held in Dubai from October 1, 2021, it said.

"Had a very useful telecon with His Highness @MohamedBinZayed. Reviewed progress in our comprehensive strategic partnership and discussed recent regional developments," Modi tweeted.

Both leaders discussed regional issues of common concern, the PMO said.

They agreed that there is no place for terrorism and extremism in the world and stressed the importance of the international community standing together against such forces, it said.

## Tourist Village Network initiative in Kashmir

Srinagar, Sept 4:

Lieutenant Governor Manoj Sinha on Friday launched the Jammu and Kashmir Tourist Village Network under Mission Youth, aimed at transforming 75 villages of the union territory known for historical, picturesque beauty, and

cultural significance into tourist villages.

Speaking on the occasion, the Lt governor said the youth-led sustainable tourism initiative will strengthen rural economy and community entrepreneurship, empowering youth and the women by providing direct and indirect employment opportunities.

Highlighting the

objective behind the initiative, Sinha said the UT Government is adopting best practices recognising the uniqueness of each village and showcasing the landscapes, indigenous knowledge systems, cultural diversity and heritage, local values and traditions, besides encouraging film shooting and offering financial incentives as well as ensuring a digital

platform to all these villages.

Emphasising on harnessing the potential of the younger population and making them self-reliant, the Lt governor reiterated the government's commitment to provide maximum and equal opportunities to the youth from different backgrounds and enabling their involvement in policies that affect them.

## Army foils infiltration along LoC in Poonch

Jammu, Sept 4:

The Army has foiled a major infiltration bid by a group of heavily armed terrorists along the Line of Control (LoC) in Jammu and Kashmir's Poonch district, officials said on Friday.

The infiltration attempt was detected by alert troops of the

Indian Army, defence spokesperson Lt. Col. Devender Anand said.

"A group of heavily armed Pakistani terrorists attempted to infiltrate along the LoC in Poonch sector last night (Thursday)," he said.

"The infiltrators were challenged and heavy firing ensued," the

spokesman said.

Owing to undulating terrain and heavy undergrowth, the terrorists managed to break contact and escape back towards Pakistan-Occupied Jammu and Kashmir (PoJK) under the cover of darkness, he said.

A thorough search of the encounter site was carried out, and a huge

quantity of supplies left behind by the terrorists was recovered, including clothing, packaged food items and medicines with Pakistani markings, Lt. Col. Anand said.

The Indian Army maintains a determined resolve to thwart any infiltration attempts or nefarious designs by anti-national elements, he said.

## Lawsuits in Texas over strict voting rules

Texas, Sept 4:

Opponents of a sweeping Republican elections overhaul in Texas sued Governor Greg Abbott yesterday, going to court even before he had signed into law changes that would further tighten the state's already strict voting rules.

Two lawsuits, filed in separate federal courts in Texas, are believed to be the first to challenge the far-reaching measure known as Senate Bill 1, which the Legislature approved this week after Democrats ended months of protests over changes that include new limits on voting hours and criminal penalties for obstructing partisan poll watchers.

Abbott said he would sign it, which could happen within days. Republicans say the bill provides safeguards against voter fraud. They also point out that it would increase the minimum number of hours during early voting and expand the number of counties where polls would have to stay open for 12 hours.

In July, the Supreme Court upheld new voting limits in Arizona that a lower court had found discriminatory under the Voting Rights Act.

## Thai PM wins confidence vote

Bangkok, Sept 4:

Thai Prime Minister Prayuth Chan-ocha has won a confidence vote in Parliament after a frenzy of speculation over the makeup of the ruling coalition.

Rumours his own political allies might try to unseat him had

recently overshadowed harsh criticism from the opposition about his government's coronavirus response.

Thai media were instead abuzz with rumours that the secretary-general of the military-backed ruling party was leading the effort to unseat Prayuth

and to add the main opposition party to the coalition.

Prayuth won 264 votes in the House of Representatives against 208 no confidence votes today.
