PM Modi has always been working for the welfare of farmers like no other PM in the past," he said. He also commended the move to open 100 new Sainik Schools in the country. "It is of great importance for our state which sees a large number of youth going into the army every year. It is also an important step in the education sector." "Overall, the budget is an inclusive one while focusing on health, welfare of poor and rural development. It will boost the growth of our country," said Rawat.
