## आप के हुए प्रदीप छबड़ा बुजुर्ग महिला का हत्यारोपी गिरफ्तार

चंडीगढ़ 13 अगस्त (जनसत्ता)।

### केजरीवाल के हाथों धामी झाड़ू

चंडीगढ़ कांग्रेस के पूर्व अध्यक्ष प्रदीप छबड़ा आज आम आदमी पार्टी- आप के हो गए। कांग्रेस से इस्तीफा देने के बाद से ही छबड़ा के किसी दूसरी पार्टी में शामिल होने के कयास लगाए जा रहे थे। आज शुक्रवार दिल्ली के मुख्यमंत्री अरविंद केजरीवाल ने छबड़ा को पार्टी की सदस्यता ग्रहण कराई।

जनकारी के मुताबिक, छबड़ा का बीते कई दिनों से चंडीगढ़ कांग्रेस अध्यक्ष सुभाष चावला और पूर्व केंद्रीय मंत्री पवन कुमार बंसल के साथ गतिविधि चल रहा है और उन्होंने एक सप्ताह पहले ही राष्ट्रीय अध्यक्ष सोनिया गांधी को अपना इस्तीफा भेज दिया था। फिर अगले

रोज कांग्रेस के राष्ट्रीय महासचिव एवं चंडीगढ़ के पार्टी प्रभारी हरीश रावत ने छबड़ा को फोन कर उन्हें इस्तीफा वापस लेने को कहा और जल्द उनसे मिलकर मामला सुलझाने की बात भी कही। छबड़ा जैसे बीते दो महीने से लगातार पवन कुमार बंसल और सुभाष चावला पर आरोप लगाते आ रहे हैं।

पता चला है कि प्रदीप छबड़ा को आप में शामिल करने के लिए पूर्व पार्षद चंद्रमुखी शर्मा ने प्रयास किया जो स्वयं भी पहले कांग्रेस के ही नेता रहे, लेकिन वह भी 3 साल पहले पवन बंसल से नाराज होकर आप में चले गए थे। फिलहाल वह 'आप' के चंडीगढ़ नगर निगम

चुनाव के प्रभारी हैं।

छबड़ा बीते 35 साल से कांग्रेस से जुड़े रहे और वह नगर निगम में महापौर और वरिष्ठ उप-महापौर भी रहे। छबड़ा के अब आप में चले जाने पर पार्टी की संयोजक प्रेम गर्ग ने उनका स्वागत किया। अब छबड़ा जल्द चंडीगढ़ में बड़ा कार्यक्रम करेंगे, जिसमें वह अपने और समर्थकों को भी पार्टी में शामिल करवाएंगे।

छबड़ा को पार्टी आलाकमान ने इसी साल जनवरी में अध्यक्ष पद से हटाया था और अब उनके आप में चले जाने से चंडीगढ़ कांग्रेस को बड़ा झटका लगा है क्योंकि दिसंबर में ही निगम चुनाव हैं।

चंडीगढ़, 13 अगस्त (जनसत्ता)।

कोविड संक्रमण में अपनी नौकरी से हाथ धोने के बाद लूटपाट की मंशा से सेक्टर-8 स्थित एक कोठी में घुसकर वहां रह रही एक 98 वर्षीय बुजुर्ग महिला जोगिंदर कौर के हत्यारोपी बाबची कैलाश भट्ट को आज शुक्रवार यूपी पुलिस ने धरदबोचा। पुलिस का कहना है कि हत्यारोपी भट्ट को नौकरी चले जाने के बाद रूप-पैसों की बड़ी किल्लत आ रही थी और फिर उसने अपनी बाइक की किस्तें चुकाने के लिए चोरी करने की मंशा से किसी घर में संध लगाने की साजिश रची।

पहले उसने सेक्टर-8 में रेकी कर पता लगाया कि वहां एक कोठी में एक बुजुर्ग महिला अकेली रहती हैं। उसने वहां काम करने वाले नौकर की रोजमर्रा की गतिविधि पर भी नजर रखी कि वह हर रोज शाम करीब 6.30 बजे आधे-पौने घंटे के लिए

सैर करने निकलता है। पुलिस ने आगे बताया कि बीती 6 अगस्त की शाम हत्यारोपी ने पीड़ित महिला की कोठी में लूटपाट की मंशा से संध लगा दी। जब महिला ने उसे पकड़ लिया तो उसने उन पर चाकू से हमला कर दिया लेकिन रसोईघर में इस्तेमाल होने वाला चाकू वह मौके पर ही छोड़ गया था। सूत्रों का कहना है कि हत्यारोपी ने सर्वेंट क्वार्टर में संध लगाई थी कि तभी जोगिंदर कौर की उस पर नजर पड़ी और उन्होंने शोर मचा दिया था।

पुलिस ने हत्यारोपी को आज दोपहर सेक्टर-4/5/8/9 के चौराहे के समीप धर लिया।

पुलिस इंस्पेक्टर सतिंदर सिंह ने बताया, 'भट्ट की नौकरी तब चली गई थी जब लोगों ने यहां बाबचियों से काम लेना बंद कर दिया था। उसी दौरान उसकी पत्नी को नवजात हुआ जिसके लिए उसने कर्ज लिया

था। इसके अलावा उसके बाइक की भी किस्तें टूटी थी।'

एसएसपी- यूटी कुलदीप सिंह चहल का कहना है कि हत्यारोपी के रक्तरंजित कपड़े आदि बरामद कर लिए गए हैं। सूत्रों का कहना है कि कोविड संक्रमण से पूर्व वह अच्छा खासा कामात रहा था और वर्तमान में वह सेक्टर-15 में अंशकालिक काम करता था लेकिन कमाई उतनी नहीं होती थी। वह सेक्टर-8 की ही एक कोठी में बीवी-बच्चे के साथ रहता था, और उसकी पत्नी भी घरों में काम करती है। पीड़ित जोगिंदर कौर ने अपनी घरेलू नौकरानी भावना को सर्वेंट क्वार्टर दे रखा है और उसने ही अपनी मालकिन को रक्तरंजित अवस्था में वहां पड़े देखा था और अपने पति को बुलाकर पुलिस को सूचित किया था। पीड़ित बुजुर्ग महिला के दो बच्चे विदेश में रहते हैं जबकि हत्यारोपी उत्तराखंड का रहने वाला है।

## हरियाणा में एक दिन में 2 संक्रमितों की मौत

पंचकूला, 13 अगस्त (जनसत्ता)।

हरियाणा में बीते 24 घंटों में 2 संक्रमितों की मौत हुई जबकि नए 26 मरीज सामने आए। आज 20 जिलों में किसी संक्रमित की मौत नहीं हुई और न ही 12 जिलों में नया मरीज ही आया। आज 1-1 मरीज न भिवानी और हिसार में दम तोड़ा। अभी संक्रमण के 664 सक्रिय मरीज हैं। आज सर्वाधिक 11 नए मरीज गुरुग्राम में जबकि फरीदाबाद-यमुनानगर में 4-4 मरीज आए और शेष जिलों में संख्या इससे कम थी।

### पंजाब में नए 89 संक्रमित

चंडीगढ़, 13 अगस्त (जनसत्ता)।

पंजाब में बीते 24 घंटों के दौरान किसी कोरोना संक्रमित की मौत नहीं हुई लेकिन प्रदेश में नए 89 मरीजों की पुष्टि आज शुक्रवार यहां जारी मीडिया बुलेटिन में हुई। अब तक पंजाब में 16,334 संक्रमित कोरोना से जान गंवा चुके हैं।

आज सामने आए उक्त 89 नए कोविडग्रस्त मरीजों में सर्वाधिक 19 संक्रमित अकेले जिला अमृतसर से हैं, जबकि 12 कपूरथला में, 10 मोहाली में, 9 बटिंडा में, 6-6 लुधियाना-फरीदकोट में, 4-4 जलंधर-पठानकोट में, 3-3 पटियाला-फाजिल्का-गुरदासपुर-मुक्तसर में, 2 फतेहगढ़ साहिब में और 1-1 नया मरीज रोपड़-मोगा में सामने आया है।

अब भी पंजाब में कोरोना संक्रमण के 568 सक्रिय मरीज उपचाराधीन हैं, जिनमें से 33 मरीजों को ऑक्सीजन के सहारे रखा गया है जबकि 3 संक्रमितों को वेंटिलेटर के सहारे रखने की जरूरत पड़ी। इनके अलावा, अति गंभीर किस्म के 12 कोरोना संक्रमितों का इलाज लेवल-3 संबंधी उपचार पद्धति के अधीन किया जा रहा है। आज पंजाब में 53 संक्रमितों को अस्पतालों से छुट्टी भी दी गई।

### चंडीगढ़ में 7 नए संक्रमितों की पुष्टि

चंडीगढ़, 13 अगस्त (जनसत्ता)।

शहर में आज शुक्रवार यहां लगातार 12वें दिन कोविड-19 संक्रमण से किसी मरीज की मौत नहीं हुई लेकिन नए 7 मरीज जरूर शहर में सामने आए। संक्रमण से अब तक 811 मरीजों की मौत हो चुकी है। अब 42 सक्रिय मरीज हैं। आज 10 संक्रमितों ने घर वापसी की। अब तक 61,171 संक्रमित स्वस्थ हुए हैं।

## पिपला लोहा ऊपर आ गिरने से 12 झुलसे, 4 की हालत नाजुक

फतेहगढ़ साहिब, 13 अगस्त (एजेंसी)।

मंडी गोबिंदगढ़ स्थित एक औद्योगिक इकाई की फरसेस में अचानक उबाल आने और पिपला लोहा गिरने से वहां कार्यरत 12 श्रमिक बुरी तरह झुलस गए। पंजाब पुलिस की ओर से आज शुक्रवार को दी गई जानकारी में बताया गया कि यह हादसा कल गुरुवार रात हुआ था। हादसे में घायल 4 श्रमिकों की हालत नाजुक बताई जाती है जिन्हें उपचार के लिए लुधियाना के एक निजी अस्पताल में भर्ती कराया गया है।

### प्रकाश सिंह बादल से मिले चौटाला

चंडीगढ़, 13 अगस्त (जनसत्ता)।

देश में तीसरे मोर्चे के गठन की कवायद में लगे हरियाणा के पूर्व मुख्यमंत्री ओम प्रकाश चौटाला लगातार जनसमर्थन जुटा रहे हैं। चौटाला ने पूर्व उपप्रधानमंत्री स्वर्गीय तारू देवीलाल के जन्म दिवस के अवसर पर देश में तीसरे मोर्चे के गठन का एलान करने की तैयारी में हैं। चौटाला ने इसे लेकर पूर्व प्रधानमंत्री एचडी देवेगौड़ा, बिहार के मुख्यमंत्री नीतीश कुमार, उप्र के पूर्व मुख्यमंत्री मुलायम सिंह सहित कई दिग्गज नेताओं के साथ मुलाकात कर चुके हैं।

## शादी को हो चुके 12 साल, 11 साल की बच्ची फिर भी शादी पंजीकृत नहीं हो रही

चंडीगढ़, 13 अगस्त (जनसत्ता)।

हरियाणा में करनाल जिला के एक दंपति की 11 साल की बच्ची होने के बावजूद शादी पंजीकृत नहीं हो रही है। रजिस्ट्रार द्वारा शादी पंजीकृत करने से इनकार किए जाने के बाद दंपति ने पंजाब-हरियाणा हाईकोर्ट में गुहार लगाई है।

इस मामले में दुल्हन की उम्र 34 साल तो दूल्हे की उम्र 30 साल का और दोनों की 11 साल की एक बच्ची भी है, फिर भी उनकी शादी अवैध है। उनकी शादी को कानूनी मान्यता नहीं मिल रही है। विवाह पंजीकरण अधिकारी ने इस विवाह को पंजीकृत करने से इनकार कर दिया है। उसने वजह बताई है कि शादी के समय दूल्हा नाबालिग था। इंद्रि तहसील के रहने वाले एक युवक ने हाई कोर्ट में याचिका दायर कर बताया कि उसका विवाह हिंदू रीति रिवाज के तहत आठ दिसंबर 2009 को हुआ था। उस समय उसकी उम्र 18 साल पांच महीने 10 दिन थी, जबकि उसकी पत्नी

की उम्र 22 साल चार महीने की थी। उनके विवाह के करीब 10 महीने बाद 15 अक्टूबर 2010 को एक लड़की का जन्म हुआ।

सात जुलाई 2021 को उन्होंने इंद्रि के तहसीलदार सह विवाह पंजीकरण अधिकारी को एक आवेदन देकर विवाह पंजीकृत करने का आग्रह किया। लेकिन, 20 जुलाई 2021 को उनका आवेदन इस आधार पर खारिज कर दिया गया कि विवाह के समय लड़के की आयु 21 साल से कम थी, जो कानूनन शादी के लिए जरूरी है।

याचिका कर्ता की दलील थी कि अब जब वह विवाह पंजीकरण करवाना चाहता है तो कानूनी तौर पर योग्य है, लेकिन विवाह पंजीकरण अधिकारी उनकी दलील को न समझते हुए विवाह के समय उनकी आयु को आधार बनाकर पंजीकरण नहीं कर रहे। उसकी इस समय लगभग 11 साल की बेटी है और विवाह पंजीकरण अधिकारी शादी को कानूनी तौर पर गलत करार दे रहे हैं।

## किसानों की तिरंगा यात्रा में भी आगे महिलाएं, ट्रैक्टरों के स्टियरिंग थामे

चंडीगढ़, 13 अगस्त (जनसत्ता)।

किसानों की तिरंगा यात्रा के अभ्यास में आज शुक्रवार हरियाणा के जिला जींद स्थित कस्बा उचाना में महिलाएं ट्रैक्टर चलाती नजर आईं जो दरअसल उप-मुख्यमंत्री दुष्यंत चौटाला का विधानसभा हलका भी है। बता दें कि किसानों ने आगामी 15 अगस्त यानी गणतंत्र दिवस पर हरियाणा के अलग-अलग हिस्सों में तिरंगा यात्रा निकालने की उद्घोषणा कर रखी है। आज शुक्रवार आसपड़ोस के गांवों से महिलाएं अपने-अपने ट्रैक्टरों पर सवार होकर तिरंगा यात्रा के अभ्यास में शिरकत करने जींद पहुंचीं जबकि उनके पुरुष सदस्य उनके बराबर वाली सीटों पर बैठे नजर आए।

गौरतलब है कि इस साल गणतंत्र दिवस पर निकाले जाने वाली तिरंगा यात्रा से पहले इस इलाके की कई महिलाओं ने बाकायदा ट्रैक्टर चलाना भी सीख लिया है। जब आज इन महिला चालकों के ट्रैक्टरों का काफिला कस्बा उचाना से होकर गुजरा तो वहां खड़े लोग उनकी तस्वीरें उतारते और वीडियो बनाते भी देखे गए।

जिला जींद के भाकियू अध्यक्ष सिकम नैन का कहना है, 'तिरंगा यात्रा का आज यह अभ्यास हमने असल में आगामी 15 अगस्त को अपना सर्वश्रेष्ठ प्रदर्शन कर दिखाने की मंशा से किया है ताकि किसी को भी हमारी वजह से परेशानी न हो। बेशक यह महिलाएं ही हमारी तिरंगा यात्रा की अगुवाई करेंगी। हम 15 अगस्त वाले रोज उन युद्धीय लोगों को महिलाओं की ताकत का नजारा दिखाएंगे जो कहते हैं कि तिरंगा यात्रा की किसान आंदोलन के समर्थक बने हुए हैं। उन्हें हम यह भी दिखाएंगे कि आंदोलन लंबा खिंचने के बावजूद हमारा हौसला टूटा नहीं है। तिरंगा यात्रा में किसान अपने-अपने ट्रैक्टरों के साथ शामिल होंगे। किसानों की योजना तो खेतीबाड़ी में इस्तेमाल होने वाले उपकरण आदि भी इसमें प्रदर्शित करने की योजना बनाई है जब गणतंत्र दिवस पर उनकी झांकी सड़कों पर निकलेगी।'

इससे पूर्व फरवरी में भी कई स्थानों पर महिलाएं किसान आंदोलन की अगुवा बनीं थीं जब किसान रेल रोक कार्यक्रम के तहत रेल पटरियों पर धरना दिए बैठे थे। तब भी जिला जींद में महिलाओं की सहभागिता उल्लेखनीय रही थी।

Mumbai: India's benchmark indices hit fresh records on Friday with the Sensex crossing the 55,000 mark and the Nifty surpassing the 16,500 level for the first time ever, led by information technology and consumer stocks. Market sentiment was aided by the latest inflation data, which showed that it eased to 5.2% in July after recording two consecutive 6% plus prints, raising hopes that the Reserve Bank of India (RBI) will persist with its accommodative monetary policy. The gradual easing of restrictions as the second Covid-19 wave ebbs and continued flows from domestic investors starved of other investment options have kept the bullish momentum intact despite worries about share valuations. The Sensex ended up 583.3 points, or 1.1%, to close at 55,437.29 after scalars an all-time high of 55,467.79 during the day. The Nifty gained 164.76 points, or 1.0%, to close at 16,529.10 after touching a lifetime high of 16,543.60 during the day.

The perception of risk in the market increased with the volatility index, or India VIX, rising 6% to 12.99 but the level is still at the lower end of the band. **Corporate Loan Growth Shrinks but Lenders Expect Revival**

Credit to industry falls 1.7% in year to date; easy liquidity, eco recovery expected to fuel demand

Environment made uncertain by the pandemic. But bankers expect a revival in corporate loan growth as the economy opens up, making a strong business case for capital expenditure. Chunky industrial loans, which make up about 30% of non-food credit, have witnessed lukewarm demand so far in 2021, with central bank data showing, underlining a trend among companies to conserve cash, the leverage as much as possible, and loans under utilization. The respective loan limits sanctioned by lenders. Retail credit demand has expanded, however, through the period of episodic lockdowns and curbs on mobility. Both analysts and bankers believe credit demand will now pick up as companies invest for the next cycle of growth. In a report published earlier this month, Japanese investment bank Nomura said growing optimism and abundant liquidity should boost loan demand. It also expects an across-the-board 100% increase in demand through Q1 2022, with export levels the highest for retail loans, followed by manufacturing and services, while infrastructure loan demand lags. Nomura said, "The simultaneous rise in loan demand and easing of loan supply conditions suggest that credit growth should eventually pick up."

An uncertain business environment led to muted credit demand from traditionally asset-heavy industries, such as industrial metals, metal products, iron and steel, construction and cement. Instead of adding more debt to their balance sheets, several companies in these sectors sought to improve their debt profiles.

Gandhinagar: Prime Minister Narendra Modi, launching the national scrappage policy on Friday, said it will attract more than ₹10,000 crore in investment, creating thousands of new jobs. The green policy provides incentives for the replacement of aging vehicles with new, environment-friendly ones. "This policy will play a big role in the modernisation of the vehicle population in the country, removal of unfit vehicles from the roads in a scientific manner," the prime minister said in an online address to an investor summit in Gujarat. Under the policy, commercial vehicles will have to be scrapped after 15 years if they fail to get a fitness certificate. In the case of private vehicles, the time limit is 20 years. The Prime Minister said the policy would create a viable circular economy of reuse, recycle and repair and will result in value for all stakeholders, while being environmentally responsible. Gujarat is seeking investments for setting up vehicle scrapping infrastructure at the summit. PM Modi said the state has first-hand experience of the benefits of formal scrapping at the ship-breaking industry at Alang. "There is both infrastructure and skilled manpower in the area. With this, it has the potential to be a hub for vehicle scrapping after ship recycling," he said.

Vehicle owners opting for scrapping will get benefits including: 5% discount from vehicle manufacturers; Road tax rebate of up to 25% from states; registration fee waiver.

**Vaccine Mixing Only if One Unavailable: Serum Chairman**

Mumbai: Serum Institute of India (SII) chairman Cyrus Poonawalla said on Friday that he was against mixing of Covid-19 vaccines, arguing that no large study had been done to prove better efficacy of a cocktail of first dose of a vaccine followed by a second dose of another vaccine. However, hours later he said that in the event of unavailability of the first vaccine, a second dose of another vaccine could be administered. "To clarify my earlier statement: For those who have been administered the first dose of a particular vaccine and in case of the unavailability of the second dose of the same — as an alternative, another vaccine can be administered. That said, the efficacy and the immunogenicity of the combination are dependent on the ongoing studies conducted by regulators," said Poonawalla, whose group firm SII is the world's largest vaccine producer by volume and produces Oxford-AstraZeneca's locally labelled Covishield vaccine. Earlier, talking to media persons after receiving the Lokmanya Tilak National Award in June, he said in response to a question on a recent Indian Council of Medical Research study which found that a cocktail of Covishield and Covaxin could provide better immunity. There is no need to mix the vaccines. If there is a reaction, then doctors will blame the one company for it, and the other will blame us. This (mixing) is not an option in a field of 100% responsibility on vaccine.
