Tech revenue growth falls to 3.8% in FY24: Nasscom

SAMEER RANJAN BAKSHI Bengaluru, February 16

THE REVENUE OF domestic technology industry, including hardware, is expected to increase to \$253.9 billion this fiscal. That represents a growth of 3.8%, compared with the previous year's 8.4%, according to industry body Nasscom's Strategic Review 2024 report.

India's technology services exports are estimated to touch \$199 billion in the fiscal year ending March 2024, a growth of 3.3% compared to FY23. The IT services revenue in the same period is estimated at \$128.4 billion. The report said that the tech sector will add 60,000 new jobs in FY24, compared to 270,000 jobs in FY23. Between 2023 and 2024, over 650,000 employees are being trained in generative AI skills.

Commenting about falling headcounts in tech industry, Rajesh Nambiar, chairperson, Nasscom said the glut after
