## Note -

- 1. Pursuant to regulation 23 of SEBI Listing Regulations, read with SEBI LODR Sixth Amendment, Regulations, 2021, Payment of dividend to the shareholders is not classified to be a related party transaction. Further, approval of Audit committee is not applicable since Dividend is offered to all shareholders uniformly in proportion to their shareholding. However, transaction is disclosed as per Ind AS 24.
- 2. Amount mentioned under the category Trade Receivable and Trade Payable forms part of the approval provided by the Audit Committee for Related party Transaction for the entity. Therefore, nil amount is mentioned against the said categories in Column L.
- 3. The amount filled in the column L titled as 'Value of Related Party Transaction as approved by Audit Committee' is inclusive of the amount incurred on deployment of additional resources at per man hour rate basis as approved by the Audit Committee for deployment of additional resources.
- 4. Approval of Audit Committee is not applicable on payment of sitting fees and commission to the Non- Executive Directors. However, Disclosure is required as per Ind AS 24.
