दनकौर स्थित खेरली नहर में रविवार रात कोहरे के चलते अर्टिका कार गिर गई। हादसे में कार सवार छह लोगों की पानी में डूबने से दर्दनाक मौत हो गई। कार में बैठे अन्य पांच लोगों को इलाज के लिए निजी अस्पताल में भर्ती कराया गया। दनकौर पुलिस ने लोगों के साथ पानी में डूबते हुए पांच लोगों को बचाया। मृतकों के शव पोस्टमॉर्टम के लिए भेजे गए हैं।

संभल के ग्राम लधनपुर के रहने वाले मल्लू के बेटे दिल्ली के मीठापुर इलाके में रहते हैं। उनके बेटों ने अपना नया मकान लिया था, जिसका सोमवार सुबह गृह प्रवेश होना था। इस समारोह में शामिल होने के लिए मल्लू अपने परिवार के महेश, किशनलाल, नरेश, राम खिलाड़ी और नेत्रपाल समेत 11 लोगों के साथ अर्टिका कार में सवार होकर रविवार देर शाम संभल से मीठापुर दिल्ली के लिए निकले थे। बताया गया है कि रविवार रात कोहरे अधिक होने के चलते दृश्यता काफी कम थी। जब कार दनकौर स्थित खेरली नहर मोड़ से होते हुए ग्रेटर नोएडा की तरफ जा रही थी, इसी दौरान रास्ता दिखाई नहीं देने पर चालक का संतुलन बिगड़ गया और जिसके चलते कार खेरली नहर में गिर गई।
