ORDER (Per Bench)

Ld. RP alongwith Ld. Counsel for the RP appears. CA(IB) 1144/KB/19 is filed by the RP for extension of CIRP period expiring on 08.09.2019. CoC in its meeting dated 27.08.2019 passed resolution by 96% votes for extension of CIRP period. We heard the Ld. Counsel for the RP. CIRP is in progress and CIRP period is extended for 90 days from 08.09.2019. In view of this **CA(IB) 1144/KB/2019 stands disposed off.**

CA(IB) 1038/KB/2019 is filed by one of the Operational Creditors, Indian Supplying Co. Private Ltd. with the request to direct RP to consider his claim. Heard the RP alongwith Counsels for the RP. RP to consider the claim as per the rules. With this direction, **CA(IB) 1038/KB/2019 stands disposed off.**

CA(IB) 702/KB/19 is filed by the RP for direction to the Commissioner of Commercial Taxes, VAT Department to release accounts in State Bank of India, Main Branch, Patna bearing no. 34843805493, which was seized by the bank at the direction of the Commissioner of Commercial Taxes, Bihar. Notice of this application is served on the authority but none appears for them. We heard the Ld. Counsel for the RP. Since the corporate debtor is admitted in CIRP, assets of the corporate debtor must go in possession and custody of RP. In view of this, SBI, Main Branch, Patna is directed to defreeze the account of the corporate debtor. RP is directed to serve copy of this order on the Commissioner of Commercial Taxes, Patna. In view of this, **CA(IB) 702/KB/2019 stands disposed off.**
