I, Arun Kumar Gupta (Membership No. 21227 C.P. No. 8003) Proprietor, M/s. Arun Gupta & Associates, Practicing Company Secretary having office at59, Ground Floor, Street No. 3, Madan Park, East Punjabi Bagh, New Delhi – 110026,was appointed as Scrutinizer by the Members of the Board of "JTEKT India Limited" ('the Company') to scrutinize the process of the Postal Ballot conducted through Remote E-voting in respect of the resolutions set forth in the Postal Ballot Notice of the Company, dated 12th September, 2022 (hereinafter "Postal Ballot Notice") issued in accordance with MCA Circulars and SEBI Circulars.

Our Responsibility as the Scrutinizer was to ensure that the voting process was conducted in fair and transparent manner and to submit a Scrutinizer's Report on the voting done in respect of the following resolutions based on the reports generated from the electronic voting system:

- Resolution No. 2

  Approval to enter into material related party transactions with JTEKT Corporation, Japan
- Resolution No. 3

  Approval to enter into material related party transactions with JTEKT Fuji Kiko Automotive India

I hereby submit my report on the voting on the aforesaid Ordinary Resolutions proposed in the Ballot Notice, as under:

### Company Secretaries

- 1) In terms of Section 108 and Section 110 of the Companies Act, 2013 read with the Rules and the Listing Regulations, the Company had appointed **KFin Technologies Limited** ("KFIN") for providing the facility of voting through electronic means ("Remote e-voting") to its members.
- 2) The Company sent the Postal Ballot Notice, along with the Explanatory Statement under Section 102 of the Act on Friday, 16th September, 2022 by the electronic mode ('e-mail') to those members whose email addresses were registered with the Company / Depository Participants, pursuant to the aforementioned MCA Circulars and SEBI Circulars. A copy of said Postal Ballot Notice was published on the website of the Company and KFIN.
- 3) In adherence to MCA Circulars, physical ballots were not dispatched, due to outbreak of COVID-19 Pandemic. Accordingly, the communication of the assent or dissent of the members had taken place through the remote e-voting system only.
- 4) As per sub rule 3 of Rule 22 of the Rules and MCA Circulars, the Company published an advertisement on Saturday, 17<sup>th</sup> September, 2022 about the dispatch of the Postal Ballot Notice in 'Business Standard' (English Newspaper All Editions and Hindi Newspaper Delhi Edition).
- 5) The members of the Company whose names were recorded in the Register of Members or in the Register of Beneficial Owners maintained by the Depositories (in case of shares held in dematerialized form) as on the cut-off date i.e.Wednesday, 14th September, 2022 were entitled to avail the Remote E-voting facility, in respect of resolutions as set out in the Postal Ballot Notice.
- 6) In terms of the Postal Ballot notice, the e-voting commenced on Monday, 19th September, 2022 (9:00 A.M. IST) and ended on Tuesday, 18th October, 2022 (5:00 P.M. IST).
- 7) All votes casted through e-voting during the abovementioned period, were considered for scrutiny and at the end of Remote E-voting period, the Remote E-voting facility was blocked by KFIN forthwith.
- 8) After the conclusion of remote e-voting, the votes cast by the members through remote e-voting facility were unblocked on Tuesday, 18th October, 2022 at 5.00 P.M. in the presence of two witnesses viz. Ms. Ekta Sharma R/oC-42, Sector-27, Noida 201301 and Ms. Jyoti R/oFlat No. 501, Sarvahit Apartments, Sector 17, Pocket A, Dwarka, Delhi 110078, who are not in employment of the Company.
