HPCL and Charge+Zone in pact to set up public charging stations

JYOTSNA BHATNAGAR Ahmedabad, August 27

AMID THE FLURRY of electric vehicle (EV) launches in the automobile sector, Vadodarabased Charge+Zone, a fast emerging tech-driven EV charging network company, has entered a tie-up with oil and gas behemoth HPCL to set up 500 end-to-end high-speed charging stations across the country over the next one year.

Founder and CEO Charge+Zone, Hariyani, exclusively told FE that the deal would provide a major push to scaling up infrastructure for the burgeoning electric vehicle (EV) market. As per the terms of the deal, while HPCL would provide the space for setting up the charging stations within their existing petrol pumps, Charge+Zone would pump in the capex of ₹200 crore with the cost of each charging station pegged at ₹45 lakh. The project is expected to commence by October this year once the company has raised the money required.

"Certain large private equity funds have given us firm commitments and we propose to fund the project through a combination of equity and debt," Hariyani revealed.

agriculture and farmers welfares report, the production of millets has increased by 16% to 17.26 million tonne (MT) in the 2019-20 crop year (July-June) from 14.5 MT in 2015-16.

India is one of the leading producers of millets in the world with an estimated share of around 41% in the global production.

Millets are grown in around 21 states including Karnataka, Andhra Pradesh, Tamil Nadu, Kerala, Telangana, Uttarakhand, Jharkhand, Madhya Pradesh and Haryana.

Millets are notified as nutricereals by the government in April 2018. The millets are a rich source of protein, fiber, minerals, iron, and calcium and have a low glycemic index. There are 11 majorvarieties of millet considered as nutri-cereals, which are produced and exported from the country. These include sorghum (jowar), pearl millet (bajra), finger millet (ragi) and minor millets (kangani).



दोनों बाप-बेटे की गिरफ्तारी स्थानीय सेक्टर-35 वासी जेन ली नामक एक विधवा चीनी महिला की शिकायत पर की गई है। सूत्रों का कहना है कि जब एएसआइ

मुकेश कुमार अपने दलबल सहित गुरविंदर सिंह और उसके बेटे को गिरफ्तार करने पहुंचे तो उसने अपने राजनीतिक रसख का रौब दिखाने का प्रयास किया। बाद में मुकेश कुमार ने पंचकूला पुलिस को दोनों के खिलाफ दर्ज प्राथमिकी से अवगत कराया।

आर्थिक अपराध शाखा में तैनात एसपी केतन बंसल ने बताया, 'हमने एक चीनी मूल की महिला के साथ संपत्ति की खरीद-ओ-फरोख्त में जालसाजी करने वाले पिता-पत्र को गिरफ्तार कर लिया है। पीडित महिला का

आरोप है कि एक सोची-समझी साजिश के तहत गुरविंदर सिंह बाली ने अगस्त, 2013 में उनकी सेक्टर-35 स्थित दोमंजिला कोठी के टाप फ्लोर का रेंट एग्रीमेंट किया था। बाद में गुरविंदर सिंह ने महिला के साथ अपने बेटे के नाम पर एक और किराये का करार कर

पंजाब/हरियाणा

लिया। कछ महीनों के बाद दोनों ने फर्जी दस्तावेजों के आधार पर किराए की संपत्ति पर स्वामित्व का दावा कर दिया।'

पुलिस का कहना है कि प्रकरण की जांच-पड़ताल में पता चला कि फर्जीवाड़ा कर तैयार कराए गए दस्तावेजों का पीड़ित महिला को पता नहीं चल पाया। करारनामों में गवाह भी आरोपियों के जानकारों को ही बनाया गया था जो पीड़ित महिला को नहीं जानते थे।

सूत्रों ने बताया कि करारनामे के मताबिक विश्वजीत सिंह ने महिला को 28 लाख रुपए दिए जो उन्हें कभी मिले ही नहीं। इस प्रकरण में सेक्टर-36 के थाने में मामला दर्ज किया गया था। वैसे गुरविंदर सिंह को वर्ष 2019 में कांग्रेस से एक बार निष्कासित भी कर दिया गया था और उसने शिअद का दामन थाम लिया था लेकिन बाद में वह फिर कांग्रेस में लौट आया था। फिर वर्ष 2022 में उसने कांग्रेस से इस्तीफा दे दिया था।

अंबाला में पांच परिजनों को मारकर खुदकुशी का मामला

मनोविज्ञानियों ने समाज के लिए चिंताजनक बताया

चंडीगढ, २७ अगस्त (जनसत्ता)।

बीते रोज अंबाला में अपने पांच परिजनों को निर्दयता से मौत की नींद सुलाने के बाद युवक द्वारा खुदकुशी करने के मामले ने अब कई सवाल खड़े कर दिए हैं। हालांकि. यह ऐसा पहला नहीं बल्कि चंडीगढ़ और पंचकूला में पहले घटित कम से कम ऐसे ही तीन मामलों में किसी शख्य ने अपने परिजनों की हत्या करने के बाद आत्महत्या कर ली। तीन मामलों में मौका-ए-वारदात से सुसाइड नोट मिले थे जिनमें रुपए-पैसों के घाटे और कर्ज को आत्मघाती कदम के लिए जिम्मेदार ठहराया

डाक्टरों और शिक्षाविद् मनोविज्ञानियों ने इन वारदातों को समाज के लिहाज से बेहद चिंताजनक बताते हुए कहा कि केवल आत्मघाती प्रवृत्तियों से निपटने, अवसाद से

बाहर आने और खालीपन भरने के लिए पर्याप्त जागरूकता ही एकमात्र जरिया है।

पीजीआइ में पूर्व सीनियर क्लीनिकल साइकालोजिस्ट प्रो आदर्श कोहली का कहना है, 'अपने परिजनों को मौत की नींद सुलाने के बाद खुदकुशी करने की घटनाओं में कई पहलू शामिल रहते हैं। इसमें पीड़ित की असहायता, उनकी मानसिक स्थिति बयां करती है कि अब सभी दरवाजे बंद हो गए हैं। अपने परिवार के प्रति लगाव और अंत में अपने सुसाइड नोट के जरिये दुनिया को यह बताने का प्रयास कि वह किस मानसिक स्थिति और परेशानियों से गुजर रहा है, भी इनमें शामिल है। अधिकतर मामलों में पीड़ित परिवार छोटे परिवार ही थे। शोध बताती है कि इन मनोविकारों से ग्रस्त लोगों में लक्षण कुछ दिन पहले ही नजर आने शुरू हो जाते हैं।'

उन्होंने बताया, 'यह घटनाएं दरअसल,



आम आत्महत्याओं से अलग होती हैं। मीडिया, टीवी चैनलों, पुस्तकों, अखबारों के जरिये जागरूकता मुहिम चलाकर इनकी पुनरावृत्ति रोकना जरूरी है।'

बीते कल शुक्रवार एक निजी बीमा कंपनी में शाखा प्रमुख सुखविंदर सिंह (33) ने अंबाला के गांव बलाना में अपने बुजुर्ग माता-

पिता, अपनी पत्नी, दो बेटियों सहित पांच परिजनों को मौत के घाट उतारने के बाद खुदकुशी कर ली थी।

पंजाब विश्वविद्यालय में मनोविज्ञान विभाग के प्रमुख डा रोशन लाल का कहना है, 'सामाजिक तानाबाने में बदलाव, परिवारों के बीच बंटती सीमाओं, जीवन शैली, सामाजिक-आर्थिक असुरक्षा और उनके खिलाफ षड्यंत्र रचने वाले उन लोगों के प्रति गुस्सा, जिन पर उनका कोई जोर नहीं चलता ही हत्या करने और आत्मघाती कदम उठाने की बड़ी वजह बनता है। अधिकतर मामलों में रुपए-पैसों का पहलू शामिल रहता है। मेरा मानना है कि ऐसी घटनाएं समाज में बढ़ेंगी। कानून का अनुपालन कराने वाली एजंसियां इस दिश में ज्यादा कुछ नहीं कर सकतीं। इन मनोविकारों पर अंकुश लगाने में सामाजिक संगठन, काउंसलर ज्यादा उपयोगी साबित हो सकते हैं।'

इससे पहले दक्षिण हरियाणा तथा उत्तर हरियाणा बिजली वितरण निगमों ने सरकार को बकाया राशि के संबंध में एक रिपोर्ट बनाकर भेजी है। जिसके अनुसार उपभोक्ताओं की तरफ सरचार्ज समेत 6523.98 करोड़ रुपये बकाया खड़े हैं।

रिपोर्ट के मृताबिक 12 लाख छह हजार 601 ग्रामीण घरेल उपभोक्ताओं की तरफ 2792.93 करोड रुपये मूल राशि बकाया है। इस पर 1276.89 करोड़

रुपये सरचार्ज लग चुका है। इसी प्रकार शहरी क्षेत्र के चार लाख 64 हजार 550 घरेलू उपभोक्ताओं की तरफ 685.44 करोड़ बकाया है। इस पर 74.38 करोड़ सरचार्ज के साथ यह राशि 759.82 करोड़ हो व्यावसायिक श्रेणी के दो लाख 21 हजार 327
