2. As on date of issuance of these financial results, the Group has not received any further written communication from the department regarding the outcome of the search, therefore, the consequent impact on the financial results for the three months ended 30 June 2024, if any, is not ascertainable. While the uncertainty exist regarding the outcomes of the proceedings by the Department, the Group after considering all available records and facts known to it, has not identified any adjustments to the current or prior period standalone financial results at this stage.
