The Company is pleased to inform that *inter se* old past pending disputes between erstwhile and existing shareholders of Mahal Pictures Private Limited (MMPL), an Associate of your company (33.33%), which is owning land and property (popularly known as "Kamalistan Studio") at Jogeshvari Vikhroli Link Road in Mumbai, has been put to rest and the concerned parties have successfully filed consent terms on June 4, 2019 in the I lon'ble Bombay High Court.
