- I, Gaurav Bachani, Proprietor of Gaurav Bachani & Associates, Company Secretaries, 1. - Company has listed its specified securities on the BSE SME Platform and hence the 4. requirement of giving Newspaper Advertisement shall not applicable as per the Regulation 47 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

5. The said appointment as Scrutinizer is under the provisions of Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended ("the Rules"). As the Scrutinizer, I have to scrutinize process of remote e-voting.

6. Management's Responsibility

7. Scrutinizer's Responsibility

Remote e-voting process

The remote e-voting period remained open from Tuesday, 26th September, 2023, at 9:00 A.M. and ends on Thursday, 28th September, 2023 at 5:00 P.M.

The votes cast during the remote e-voting were unblocked on Friday, 29th September, 2023, after the conclusion of the AGM and were witnessed by two witnesses, who are not in the employment of the Company.

Thereafter, the details containing, inter alia, the list of Equity Shareholders who voted "in favour" or "against" on each of the resolutions that were put to the vote, were generated from the e-voting website of National Securities Depository Limited. Based on the report generated by National Securities Depository Limited and relied upon by me, data regarding remote e-voting was scrutinized on a test check basis.
