The bid Price is inclusive of GST and other imposition may be levied under the Applicable laws. NHAI shall deduct GST as applicable, out of the eligible payments to be made during execution. It is also requested to furnish within Thirty (30) days of issue of this LoA, irrevocable and unconditional Bank Guarantees in accordance with Clause 31 of RFP, towards Performance Security amounting to Rs.7,32,13,743/- (Rs.Seven Crore Thirty Two Lakh Thirteen Thousand Seven Hundred and Forty Three only) and Additional Performance Security of Rs.3,66,06,871/- (Rs.Three Crore Sixty Six Lakh Six Thousand Eight Hundred and Seventy One only). These Bank Guarantees shall be as per relevant formats given in the RFP. The Performance Security shall be valid until 60 (sixty) days after the defects Liability Period. The Additional Performance Security shall be valid until 28 (twenty eight) days after Project Completion date.
