The SCN came to our attention only on 10th January 2024 through our GST consultants.
3	Details of the violation(s)/contravention(s) committed or alleged to be committed	The said SCN mentions that the company has not correctly availed input tax on its inward supplies and not correctly declared tax on outward supplies on reconciliation of turnover in GSTR-09 for the financial year 2018-2019.
4	Impact on financial, operation or other activities of the listed entity, quantifiable in monetary terms to the extent possible.	As per details given above in point no. 1, the SCN has no material impact on the financial, operation and other activities. Based on the advice of our tax consultants, SCN is based on erroneous calculation of turnover by the GST authorities. The Company will be filing appropriate responses to the said SCN within the prescribed timelines.
