Delhi New CM to be chosen from MLAs?

The Bharatiya Janata Party (BJP) will finalise the name for the Chief Minister's post in Delhi only after Prime Minister Narendra Modi returns from his US visit, sources said on Thursday, adding that the pick will be from the MLAs and there will be no deputy CM.

According to party insiders, BJP National President J.P. Nadda has stated that the Chief Minister will be selected from among the elected MLAs, and the Legislature Party meeting to decide the leader will take place only after the PM's return.

Sources have indicated that one of the foremost priorities of the new BJP-led government will be the cleaning of the Yamuna River. Work on this front has already started, with the party keen on de-

RJD chief Lalu Prasad on Thursday asserted that Delhi election result would leave no impact on Bihar assembly election due in October-November as BJP stood no chance of forming a government in the state. While talking to newspapers, Lalu said, "Delhi election result will have

ADITYA THACKERAY MEETS RAHUL, KEJRIWAL

Shiv Sena (UBT) leader Aditya Thackeray met Congress leader Rahul Gandhi and AAP convener Arvind Kejriwal, days after their losses in the Delhi assembly polls, with a message to strengthen the fight for free and fair elections.

Aditya Thackeray, on a whirlwind tour of the national capital, also met the party's parliamentarians amid reports of dissent in the ranks and some leaders planning to join the Eknath Shinde-led Shiv Sena. He met Gandhi late on Wednesday and called on Kejriwal, the former Delhi chief minister, whose party faced defeat in last week's assembly elections on Thursday.

After calling on Kejriwal, Aditya Thackeray described the meeting as a gesture of friend-

Court acquits MLA Kappan in cheating case

Two-time opposition legislator Mani C. Kappan on Thursday got major relief when a court here exonerated him in a 15-year-old alleged cheating case.

Kappan, a multi-faceted personality before becoming a legislator, was a film producer and has also donned the grease paint in a few Malayalam films.

The exoneration order came from a special court in Ernakulam which tries criminal cases against MPs/MLAs. The case against him was filed on the basis of a complaint filed by one Dinesh Menon alleging that Kappan had borrowed Rs 2 crore from him in 2010 but had only repaid Rs 25 lakh.

SUICIDE BID Man who rescued Pant after car crash fights for life

The man who helped save the life of Indian cricketer Rishabh Pant following a car accident in 2022 is battling for his life at a hospital near here after consuming a pesticide along with his girlfriend in a suicide bid.

According to the medic, Rajat's condition is improving. The cricketer may come to Jhabreda in a day or two to visit Rajat, the doctor said quoting the cricketer's PA.

Rajat and his friend Nishu were the first to see Pant's Mercedes car crash near Manglaur on the Delhi-Dehradun highway ahead of

Rajat Kumar (25) and his 21-year-old girlfriend consumed pesticide three days ago when their families opposed their marriage citing caste issues. His girlfriend died but he is fighting for his life at a private hospital in Jhabreda, a doctor treating him told PTI.

Roorkee in the early hours of December 30, 2022, and immediately rushed to his rescue without knowing who he was.

They pulled Pant out of the mangled car and rushed him to a hospital nearby. Their timely help was acknowledged by the cricketer in a post on social media later describing them as "heroes".

Cop's wife files complaint against husband

The wife of a senior police officer has lodged a complaint against her husband in Bengaluru, alleging that he is having an affair with a female colleague. She has also accused her husband and his alleged lover of plotting to kill her.

Screenshots of private conversations between the two police officers have surfaced and gone viral on social media. The complaint was filed at the High Grounds police station in Bengaluru.

Senior advocate Greeshma, speaking to the media, stated, "My client, the complainant in the case, has filed a police complaint against her husband, who serves as an Assistant Commissioner of Police (ACP). The complaint has been lodged against her husband, his female police officer friend, and the female officer's parents."

The accused officer married the complainant in 2014, and they have an eight-year-old child. Before joining the police force, the accused worked as a doctor. He is currently serving in the Cyber Crime Branch in Bengaluru, while the female police officer is working as an ACP in the Cyber Crime Branch in Karwar city, the advocate stated.

According to the complainant, the female officer repeatedly sent messages to the accused. When the wife confronted her husband about it, she was allegedly tortured and assaulted.

The complainant has also accused the female officer of physically attacking her. Following her complaint, a case has been registered at the High Grounds police station, and an investigation is underway. WhatsApp chats between the accused officers, in which they discussed the complainant, are also being examined.
