Thousands throng to watch Indian team train

Border-Gavaskar Trophy: Hardly anyone to watch Australian team

SRIRAM VEERA Adelaide, December 3

"THEYTOLD ME it will be busy, but this busy, huh!" The elderly lady at the entrance of the Adelaide Oval says with a smile.

Around her, utter chaotic joy

prevails as at least 3,000 fans storm through just to see the Indian team practice. Dhol beats, cries of 'jeetega bhai jeetega', 'Kohli Kohli' and 'Rohit Rohit' ring in the air. It was an open session for fans to watch the Australian and Indian teams training. There were hardly any people to watch the Australians train in the afternoon but around 5 pm, they blew in like a storm to see the Indians, shocking the lady at the gate.

Around 6 pm — the Indians had a long training session that started even before 5 pm and ended nearly three-and-a-half hours later - a group of at least 20 Australian schoolkids in uniform ran in to see them. There was no such group for the Australians training. They weren't kids of Indian origin either, such is the attraction of this Indian team Down Under.

The official training was

supposed to start at 5:30 pm local time, and it did, but two Indians were at nets an hour earlier: captain Rohit Sharma and Rishabh Pant, who hit the batting nets straightaway, before the crowd came in.

Rohit's training in particular was interesting."Yaar, gaddha haiidhar! (There is a hole/dent)" he said about an area of the ground at the popping crease of the first net he went into bat. There are four nets at the Adelaide Oval, and he chose to carry on in that particular one as it didn't upset his rhythm.

The skipper stood carefully, his back leg cutting the popping crease line. The dent was particularly bad just behind the crease. Even as a support staff suggested rather naively that he could perhaps stand a touch ahead, Rohit replied, "arre! I want to stand here".

And so he stood, back leg on the crease line. His first movement was opening that front leg that pressed forward at an angle towards the bowler. Rohit has a rather visible twitch of both feet as the bowler is about to enter the delivery stride, his knees flexing, and the front foot opening out a touch. This was his main focus in the nets.

Rohit was seen discussing with assistant coach Abhishek Nayar if he was getting the

stance and movement right.

In his first stint, before the other players came, Rohit faced newshinyballs.Does that mean he might yet open the innings in the Adelaide Test or was it to just ensure that he faced deliveries that seamed a bit - as new balls tend to do. Once the rest of the team joined him at the batting nets after warm-up and catching practice, he faced old balls.

In each of the four nets, two batsmen were together. If the pairings are anything to go by, Rohit was paired with Pant. One batsman facing a few balls, and anotherat the non-striker's end. KL Rahul and Yashasvi Jaiswal; Virat Kohli and Shubman Gill;

Rohit and Pant; Washington Sundar and Nitish Reddy. That indicates Jaiswal and Rahul as the openers, Gill and Kohli the No.3

and No.4, respectively, and so on. But all that's speculation. Eitherway, suffice to say Indians practised long, hard, and rather

intensely, with at least 3,000 people hollering around them.

Incidentally, head coach

Gautam Gambhir, who had gone to India after the Perth Test and missed the warm-up game in Canberra, was back and stood behind the stumps at one of the four nets. Arms crossed, face as intense as ever, he was almost motionless watching proceedings. Now and then, when Rohit was between his stints from one net to another, they would have a short chat, but for the main part, Gambhir stood there like a statue, observing everything quietly. Just like the statue of Clem Hill, who played in the early 1900s, that stands outside the arena, near the road across the river that shimmered in the afternoon sun.

Inside though, the Indians, and for that matter Australians, were smashing the ball. The last word, however, goes

to that security lady.

"How many people turn up for nets for the Indians in your country?!" Oh, it's not open to the public there. And she goes "Makes sense, I can see 10,000 landing up. How will people like me manage, then?!"

A WEEK after 56-year-old Laishram Kamal Babu went missing from a military garrison in Manipur's Leimakhong, a Division Bench of the Manipur High Court on Tuesday ordered the state to constitute a committee to probe the circumstances of his disappearance. Tuesday also saw a protest by women, including Kamal Babu's wife Belarani Singha, who blocked the road leading to the garrison demanding that he be rescued.

The Leimakhong military garrison is the headquarters of the Army's 57 Mountain Division and is located at the border of Meitei-majority Imphal West district and Kuki-Zomi-majority Kangpokpi. Kamal Babu worked at the garrison as a supervisor for a contractor with the Military Engineering

The High Court ordered that a committee comprising the District Magistrate of Kangpokpi district, an official of the 57 Mountain Division, and the SPs of Kangpokpi and Imphal West submit a detailed report before the next hearing scheduled for

Laishram Brajabidu, the younger brother of Kamal Babu — who is from the Meitei community - had filed a habeas corpus petition at the Manipur High Court on November 27, alleging that his brother had been kidnapped by Kuki militants from the high security zone. Kamal Babu's family said he had not returned home after going to work to the military garrison on November 25. They said that after reviewing CCTV footage with officials at the garrison, he could be seen entering the campus that morning, but not leaving it.

Azero FIR was registered in connection with the disappearance. The Manipur Police and the Army have been undertaking search operations for the past week to locate him in and around the military garrison, deploying troops, helicopters, drones and tracker dogs

Meanwhile, his wife was among a group of women protesters on the road that leads to Leimakhong military garrison on Tuesday, holding a placard reading: "I want my husband back."

"I am protesting here today, pinning my hopes on the government and the GOC of the military division that my husband will be safely handed over to me," she said.

Originally from Assam's Cachar district, Kamal Babu had been living in Imphal West for work. According to Belarani, her husband has worked in Manipur for more than 20 years, working on various contract projects, including at the Leimakhong

"I urge the Manipur and Assam governments to ensure my husband's safe return," she said.

Members of Apex Body Leh (ABL) and Kargil Democratic Alliance (KDA) — the two organisations leading the movement for statehood and other demands – met the minister at North Block. After the meeting, KDA leader Sajjad Kargili told The Indian Express that the MHA "agreed to provide 95 per cent reservation in jobs for locals of

Ladakh". This reservation, according to

those who attended the meeting, extends to

both gazetted and non-gazetted posts in the

The lack of government recruitment in Ladakh since its separation from the former state of Jammu and Kashmir has been a maior concern for its residents. The Union Territory of Ladakh does not have its own public service commission, and is now not included in the recruitment process in J&K. This has deepened the unemployment crisis in the region

Former Ladakh MP and ABL leader Thupstan Chhewang, who is also part of the HPC, said, "The meeting took place in a cordial atmosphere and an important step has been taken in resolving the issues of the people of Ladakh. We have a firm commitment from the government on recruitment

and they have said that this will begin within the next three months.'

On other points of agenda, including statehood for Ladakh, Chhewang said "those issues cannot be resolved immediately so we have agreed to discuss our fourpoint agenda in the next meeting".

"We are keen that the government continue the process of dialogue with Ladakh, so that all issues of the people can be resolved," he said. The next meeting of the HPC is scheduled for January 15.

He said that since Ladakh cannot have its own PSC in the absence of a legislature the representatives have called for Ladakh to remain combined with J&K's PSC.

In January 2023, after months of agitations within and outside Ladakh, the J&K and Ladakh Division of the MHA had issued an order constituting the HPC to discuss measures to protect Ladakh's "unique culture and language", considering its geographical location and strategic importance. Its mandate includes "ensuring the protection of land and employment for the people of Ladakh".

However, with differences over the constitution as well as the agenda of the HPC, the representatives held their first meeting with the MHA in December 2023. After four rounds of discussions, talks broke down in March this year, with the ABL and the KDA remaining firm on their four-point agenda.

The four demands are: statehood for Ladakh, safeguards under the Sixth Schedule of the Constitution, reservation of jobs for the youth of Ladakh, and creation of separate parliamentary constituencies for the two parts of the region.
