Sub: Outcome of the Board of Directors' Meeting held on 05th Oct, 2023

Dear Sir,

This is with reference to the above captioned subject and pursuant to Regulation 30 of SEBI (LODR) Regulation, 2015; we would like to inform you that the Board of Directors of the Company in their meeting held on 05th October 2023 (commenced at 11.00AM and concluded at 11.40AM), have approved the formation of subsidiary in M/s Bored Beverages Private Limited, a company engaged in the fast growing Ready to Drink (RTD) sector of the alcoholic beverages industry. The Additional Disclosure pursuant to Part A of Schedule III of the LODR Regulations are as follows:-

- 1. Globus Spirits Limited will be making an investment Subject to maximum of Rs,6Crs in this subsidiary.
- 2. Globus Spirits Limited will have majority shareholding @ 51.13% along with management control in the said subsidiary.
- 3. RTD market in India volume size- was 3.82 Cr Liters in FY 20 and expected to grow to 6.56 Cr liters by FY 25.and as per the latest reports the RTD market is estimated to witness progress at a compound annual growth rate of 10.29% (in value) and 12.15% (in volume) over the forecasted period. The growing interest in alcoholic ready-to-drinks among young urban adults, especially among consumers aged 20 to 35-years-old, is supporting the market's growth in India. This trend is being encouraged by rising disposable income levels and a growing number of bars/pubs across major cities. Further, strong new product development is boosting the sales of alcoholic RTDs in the country. Consumers are thus gaining access to a wide range of options, including products specifically developed for Indian tastes.
- 4. <u>Bored Beverages P Ltd</u>- was incorporated in 2020 by Anant Gupta and Vinayak Malhotra and is an innovative alcohol beverage startup with a vision to create an aspirational cross-category portfolio of beverages targeting millennials and Gen Z. In September 2021, they initiated their market entry by launching No Label Original Mead in Mumbai and Pune. By June 2022, they had expanded to Delhi and Haryana. In September 2022, they successfully secured seed capital from Inflection Point

Ventures. As of March 2023, they have achieved significant traction, crossing 1.2 lakh pints of No Label Original Mead in Delhi and Haryana, capturing a 7% market share in Delhi.
