At 02.00 p.m., Mr. Chakraborty – Company Secretary commenced the meeting by welcoming the Members to the 39th Annual General Meeting (AGM). Then Mr. Chakraborty announced that the requisite quorum being present, the meeting was called to order.

- Mr. Chakraborty further informed that the Ministry of Corporate Affairs ('MCA'), Government of India, permitted to conduct the Annual General Meeting ('AGM') through video conferencing (VC) or other audio visual means (OAVM) and dispensed personal present of the members at the meeting. He further informed that Company had tied up with Bigshare Services Pvt. Ltd. to provide facility for voting through remote e-voting, for participation in the AGM through VC / OAVM facility and e-voting during the AGM. He thanked all the members of the Company for joining the meeting virtually.
- Thereafter, Mr. Chakraborty commenced the formal agenda of the AGM and with the consent of the Members present, the Notice convening the meeting, the Report of Board of Directors along with annexures thereto and the Financial Statements for the financial year ended 31st March, 2024 as circulated to all the members in compliance with the relevant circulars of MCA were taken as read.
- Mr. Chakraborty informed that Annual Financial Statements of the Company for the financial year ended 31st March, 2024 did not contain any qualifications, observations or comments on financial transactions or matters, which had adverse effect on the functioning of the Company. Since there were no such qualifications, observations or comments, the Auditors Report was not required to be read.
- Mr. Chakraborty informed that the Company had provided the facility of e-voting to its Shareholders to exercise their right to vote on the Resolutions proposed to be passed at the AGM during the AGM using the e- voting website of CDSL.
