**Crude Steel Production 13.38 Lakh tonnes for Oct'20**

The Crude Steel production for the month of October, 2020 was at 13.38 lakh tonnes showing a growth of 4% over Sep 2020 (MoM) and 7% over October 2019 (YoY). The average capacity utilisation improved to 89% during the month of October 2020.
