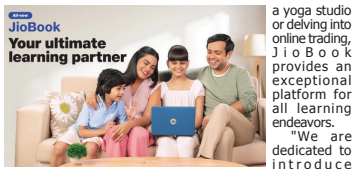

Brookfield signs MoU with Reliance Industries

Ahmedabad, Brookfield Asset Management has signed a Memorandum of Understanding (MoU) with Reliance Industries, a Fortune 500 company and India's largest private sector enterprise, to explore opportunities to manufacture renewable energy and decarbonization equipment in Australia. The MoU aims to both accelerate and de-risk Australia's energy transition by enabling it to locally produce clean energy equipment such as PV modules, long duration battery storage and components for wind energy. Under the terms of the MoU, Brookfield will work with Reliance to explore avenues of direct capital investment and development of skills, knowledge and expertise in the renewable energy sector of Australia to cater to the nation's transition to a net zero future. Reliance and Brookfield will evaluate the establishment of advanced operations in Australia to make/or assemble equipment used in the construction of renewable energy projects supplying equipment to all players in the market including Origin Energy Markets. Reliance has strong expertise in solar panel technology and long duration battery storage technology. It is currently in the process of setting up one of the world's largest integrated renewable energy manufacturing facilities in India. The MoU with Reliance is one of the key initiatives being undertaken by Brookfield to bring global manufacturing technology and expertise to Australia. In March this year, it signed a binding agreement with EIG to acquire Origin Energy. The proposed acquisition is currently going through the relevant approvals processes. As part of its proposed acquisition of the origin Energy Markets division, Brookfield has secured several institutional partners and global institutional investors GIC and Temasek have set up a plan to invest between A\$20 billion and A\$30 billion over the next ten years to accelerate its energy transition.

Japanese Foreign Minister Hayashi visits India

New Delhi Japanese Foreign Minister Yoshimasa Hayashi is on a two-day visit to India. He rode the Delhi Metro on Friday (July 28). His pictures have been shared by the Ministry of Foreign Affairs of Japan. Meanwhile, staff and security were present with him. Japanese Foreign Minister Yoshimasa Hayashi reached Delhi on July 27. He is on a two-day visit to India. This is his second visit to India this year. Before this, he had come to India on March 23 for the quad country meeting.



This is the 15th strategic dialogue between India and Japan, in which the two countries' global partnership is being discussed. In fact, Japanese Foreign Minister Hayashi is visiting a group of South Asian countries. Indian Foreign Minister Jaishankar and Japanese Foreign Minister Yoshimasa Hayashi attended the India-Japan Forum. During the program, S. Jaishankar said that Japan means a lot to India. Japan has made amazing advances in technology over the past few years. India is making great progress under the leadership of Prime Minister Narendra Modi. Praising Japan, Jaishankar also said that there is a natural partnership between Japan and India. Japan has done the job of revolutionizing India in real sense. Suzuki has an important contribution in this. We can mention in this metro, high speed train, emerging technology and semi conductor. Japan will invest up to 5 trillion yen ie 1 lakh 20 thousand crore rupees from 2022 to 2027. It will have areas of technology, semi-conductor and digital per infrastructure (DPI) investments. The two leaders held talks on the presidency of the G-20 and G-7.

SMC suspends 3 AAP councillors from board

Among those suspended include Dharmesh Bhandari, the leader of the opposition. During the general board meeting, Bhandari raised his voice over opposition members not being allowed to speak on important issues. Bhandari had requested time for an AAP councillor to speak during zero hour. As his request was declined, Bhandari protested and entered into an argument with the mayor. Despite being asked to stop, Bhandari made persistent attempts to speak and was suspended. "In a planned manner, they (ruling BJP) ensured that opposition members do not get time to speak. I objected to it. Further, to suppress the voice that exposed BJP's irregularities they suspended me," alleged Bhandari. During the meeting, AAP councillor Payal Sakariya was suspended following an argument over appointments of senior SMC employees. Sakariya raised objections over the appointment of two senior officials using special powers. She asked why the procedure for appointments of these officers was not followed. Another AAP councillor, Vipul Shrivastava was suspended allegedly for passing comments during the meeting.

IDFC FIRST Bank Q1 FY24 Profit After Tax up 61% YoY at Rs. 765 crore

Ahmedabad, The Board of Directors of IDFC FIRST Bank, in its meeting held today, approved the unaudited financial results for the quarter ended June 30, 2023. Net Profit for Q1-FY24 grew 61% YOY from Rs. 474 crore in Q1-FY23 to Rs. 765 crore in Q1-FY24 driven by strong growth in core operating income. Core Operating Profit (pre provision operating profit excluding trading gains) grew strongly by 45% YOY from Rs. 987 crore in Q1-FY23 to Rs. 1,427 crore for the quarter Q1-FY24. Net Interest Income (NII) grew 36% YOY from Rs. 2,751 crore in Q1-FY23 to Rs. 3,745 crore in Q1-FY24. Net interest Margin (gross of IBPC and S&D) was 6.33% in Q1-FY24 as compared to 5.77% in Q1-FY23 and 6.41% in Q4-FY23.
