Woman gang-raped inside New Delhi station, 4 railway employees arrested

NEW DELHI, JULY 23 -- /A woman was allegedly raped by two railway employees in a room at the New Delhi station, the national transporter said on Saturday. Four railway employees, including two who stood guard outside the room, have been arrested. All the four accused work in the electrical department, the Railways said. The woman, who was found on platform 8-9 on Friday, narrated her ordeal to officials and

they informed the Railway Protection Force (RPF), it said. The woman told the officials that she has been separated from her husband for the last one year and is engaged in a court case for divorce. Around two years back, she came in contact with a man through a common friend. The man told her that he is a railway employee and can arrange a job for her too, it said. Both of them continued talking on the phone. On July 21, the accused invited her to his house for a party to celebrate his son's birthday and for buying a new house, according to the Railways. He picked up the woman from Kirti Nagar metro station around 10.30 pm and brought her to

platform 8-9 at the railway station. He asked her to sit in a hut for electrical maintenance staff, the national transporter said. Later, the man came to the hut along with his friend and bolted it from inside. The two sexually assaulted the woman one after another. Two accomplices of the accused facilitated the assault by guarding the room from outside, it said.

All the four accused have been arrested. They were produced before a local court, which sent them to judicial custody, the Railways said. (PTI)

Chhattisgarh govt to soon start process to recruit 10,000 school teachers: CM Baghel tells Assembly

RAIPUR, JULY 23 --/The Chhattisgarh government has announced that it would soon start the process for recruitment of 10,000 school teachers in the state, where Assembly elections will be held next year.

Chief Minister Bhupesh Baghel made the announcement in the state assembly on Friday evening while answering to a debate on the demand proposals for the first supplementary budget of the ongoing financial year 2022-23. "The process of recruitment of 10,000 new teachers will be started soon. Since 1998, the state government has recruited 14,000 teachers so far..." he said. Baghel said that as many as 163 mobile veterinary units would be rolled out soon for the treatment of animals, for which a provision of Rs 10 lakh has been made in the supplementary budget. In the supplementary budget, a provision of Rs 266 crore has been made for giving dealer margin amount to operators of Public Distribution System (PDS) shops under universal PDS scheme, Rs 100 crore for gram distribution in scheduled and general areas, Rs 250 crore for the construction works and

procurement of medical equipment for medical colleges in Korba, Kanker and Mahasamund and a Cancer Institute in Bilaspur, Rs 25.50 crore for setting up 'devgudi' and 'ghotul' in tribal areas, he said. Devgudi are places of worship of tribals, while ghotul is a tradition as per which young boys and girls come to celebrate any festival at a place called ghotul and they are free to choose their own life partner there. "Despite the Centre slashing the state's due share of financial resources, the state's revenue receipt in the financial year 2021-22 was Rs 79,688 crore, which includes the revenue receipt of Rs 41,000 crore from the state itself. While from the Centre it stood at Rs 38,688 crore," he said. During the second wave of coronavirus pandemic, the state government had borrowed a market loan of Rs 4,000 crore to arrange necessary resources for public welfare works and capital expenditures in the first quarter of 2021-22. Out of this loan amount, Rs 3000 crore have been paid, the chief minister added.

After discussion, the supplementary budget of Rs Rs 2904.42 crore for the ongoing fiscal was passed in the assembly. With the passage of the first supplementary budget, the size of the total state budget increased to Rs 1,15,507 crore for the financial year 2022-23. (PTI)

CBSE board exams being split in 2 terms reason behind improved results: Schools

NEW DELHI, JULY 23 --/The rise in pass percentage in board exams as against the pre-pandemic scores can in part be attributed to the 2021-22 academic session being split into two terms, according to school principals.

In a first such instance, the academic session was divided into two terms last session. While the first term exams were conducted during November-December, the second term exams were held in May-June. "Students had more time and comparatively lesser syllabus to cover, perse and revise in the days and preparatory leaves preceding the commencement of terminal exams, Pallavi Upadhyaya, Principal, DPS RNE, said. It has naturally led to a more refined comprehension and understanding of topics, which has also led to an improvement in their answer writings. They are better able to grasp the chapters, with more time in hand and also do sufficient revisions before going to give exams," she said. According to Sangeeta Hajela, Principal, DPS Indrapuram, the split was naturally more efficient, than to prepare for a vast exam syllabus for one final exam. "As they have a comparatively shorter syllabus to grasp, it has led to an increase in their understanding levels, retention capacity, and revision-focused studies. The terminal exams have left a room open for repeated revisions, which students earlier used to ignore due to the enormous syllabus they had to study for, Hajela said. The clearer understanding of topics is also depicted in their answer scripts, where they

are emphasising more on writing value-based answers rather than long, trite answers," she said. The results for the 2022 examination for classes 10 and 12 were announced on Friday. A total of 92.7 per cent of students cleared the Class 12 exam, and 94.40 per cent passed the Class 10 exam. In Class 12, 1,34,797 students scored above 95 per cent and 33,432 scored above 90 per cent. In Class 10, 64,908 candidates scored above 95 per cent and 2,36,993 scored above 90 per cent. "With more time and less syllabus to cover due to the terminal exams, students are able to perform well in exams, with most of them scoring above 90 or 95 pc. The syllabus was divided, and it had eased off the study pressures on students and reduced the dependency on midnight revisions," said Anshu Mittal, Principal, MRG School, Rohini.

"They had reduced syllabus to grasp in each term, leading to a more concrete and crisp understanding of subject topics and chapters. It is clearly reflected in their pre-board answer writing practice and mock tests. It depicts a more precise, clear, and pristine discernment of complex and abstruse topics, which fetches them more marks for clarity and expression in the terminal exams," she added. The board decided to accord 30 per cent weightage to first term and 70 per cent weightage to second term exams for computation of final results. Pooja Bose, Principal, Pacific World School, Greater Noida, said since the Board exams took place in two terms, it had definitely increased students' efficiency as the syllabus distribution was even.
