Sub: Cessation of wholly owned subsidiary Company- Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to inform you that Keyorbit Realtors Private Limited ("**Keyorbit**") a wholly owned subsidiary of Keystone Realtors Limited ("**Company / KRL**") has raised funds by way of issuance of equity shares for which an Investment Agreement has been executed between **Keyorbit**, MT K Kapital Trust (through its scheme Mt K Resi Development Fund) ("**Investor**") and Company.

Therefore, the Investor has subscribed 9,900 fully paid-up equity shares of Rs 10/- each of **Keyorbit** which is equivalent to 9.9% of the post issue paid up equity capital. Due to this the **Company's equity shareholding in Keyorbit is diluted to 90.1%**.

Consequently, Keyorbit ceased to be a wholly owned subsidiary of Company.
