Dear Sir,

As required under Paragraph 5 of the Securities and Exchange Board of India circular SEBI/HO/DDHS/DDHS/CIR/P/2020/44 dated March 23, 2020 - Encumbrance on units of Real Estate Investment Trusts (REITs) ("**SEBI Circular**"), we wish to intimate you that the pledge created over 7,19,83,600 Units held by the Sponsor Group entities listed below, was released on June 23, 2020.

As intimated pursuant to our disclosures dated June 24, 2019 and October 4, 2019, a pledge was created over an aggregate of 33,19,91,780 Units held by certain Sponsor Group entities in favour of Deutsche Bank AG, Mumbai Branch, in its capacity as the security agent, in relation to a credit facility availed by I-REIT ML (NQ) LTD from specific overseas banks.

Of these pledged Units, please note that the pledge created over 7,19,83,600 Units (held by the Sponsor Group entities named below), aggregating to 9.33% of the total unitholding of the REIT, has been released on June 23, 2020.

As on June 23, 2020 (the date of revocation of the pledge), the Blackstone Sponsor, together with the Blackstone Sponsor Group holds 4,267,63,588 Units, aggregating to 55.30% of the total unitholding of the REIT, of which 26,00,08,180 Units, aggregating to 33.69% of the total unitholding of the REIT, are encumbered.

Dear Sir,

This is pursuant to the pre-clearance letter dated June 22, 2020 provided to us for the sale of up to 8,52,36,800 Units held by us in the Embassy Office Parks REIT.

As required under the pre-clearance letter, and the Code on Unpublished Price Sensitive Information and Dealing in Units of the Embassy Office Parks REIT (the "Code"), we wish to inform you that:

- (i) The entities named below (forming part of the sponsor group of the Embassy Office Parks REIT) have sold and transferred 6,71,13,600 Units (aggregating 8.70% of the total outstanding Units of the Embassy Office Parks REIT) ("**Transferred Units**"), currently traded on the BSE Limited and the National Stock Exchange of India Limited, pursuant to a bulk trade undertaken on the stock exchange platforms (the "**Trade**") on June 24, 2020.
- (ii) In anticipation of the Trade, we had (pursuant to the pre-clearance letter dated June 22, 2020) secured the release of encumbrance over 7,19,83,600 units ("**Released Units**") (Details of the creation of encumbrance over these Units were intimated to you pursuant to disclosures dated June 24, 2019 and October 4, 2019). Given that only 5,81,24,800 Released Units formed part of the Transferred Units, the balance Released Units will need to be re-pledged (we will submit an application for pre-clearance in this regard).

The Blackstone Sponsor Group held an aggregate of 42,67,63,588 Units, aggregating 55.30% of the total outstanding Units of the Embassy Office Parks REIT prior to the Trade, of which 33,19,91,780 Units, aggregating 43.02% of the total outstanding Units of the Embassy Office Parks REIT were pledged. Post the Trade, the Blackstone Sponsor Group holds 35,96,49,988 Units, aggregating 46.61% of the total outstanding Units of the Embassy Office Parks REIT, of which 26,00,08,180 Units, aggregating to 33.69% continue to remain pledged.

The total outstanding Units of the Embassy Office Parks REIT is 77,16,65,343 Units as on June 24, 2020 and this has remained unchanged pursuant to the Trade.
