EDITORIAL

ongress has embarked on a Bharat Jodo Yatra from Kanyakumari to Kashmir Wednesday under the leadership of Rahul Gandhi. But the Yatra will not pass through Gujarat and Himachal Pradesh which are election bound states. May be these states are excluded from the proposed Yatra because Rahul might be fearing more leaders may leave the party. Though Congress says that the intention behind such Yatra is not political, everybody knows that political parties's any step is only with the intention of taking political mileage. The current Yatra of Rahul Gandhi is also politically inspired. There is one main intention that Congress wants to every other party that grand old party is not silent or mute and it is doing something. Secondly, after the attack of Ghulam Nabi Azad, Rahul may have taken seriously his criticism and is showing that he is still active in party affairs. Anyhow, whatever the intention be, such Yatras generally do not result in success. Some Yatras bring success to the party like Lalkrishna Advani's Rathyatra (Yatra from chariot) had brought to BJP. After the huge debacle at the hands of Congress in 1984 in the first election after the brutal assassination of Indira Gandhi, BJP has come down to two seats in Loksabha. Due to Advani's Rathyatra embarked on Ayodhya issue, BJP reached to one hundred and eighty six seats in next LS polls. Gopinath Munde, a prominent leader from Maharashtra BJP has shown courage to embark on mission against the corruption of NCP president Sharad Pawar, it brought power to BJP-Shivsena coalition in the state. But it is not that all the Yatras bring success. Former prime minister Chandrashekhar had carried out a Yatra but is did not get any success. In its conclusion ceremony, a very few people were present. It is very difficult to say whether Rahul's Yatra will change fortune of Congress. But if workers and especially leaders get some inspiration and get activated by his Yatra, this will be a great success for the party which is already on the brink of collapse. The Yatra may ignite workers' to fight against Modi and BJP. Still it looks impossible that Rahul can give a waking up call for workers because Rahul has not that Karishma. His grand mother Indira Gandhi after her loss in election, had visited Belchi, a village in Bihar where several Dalits were killed by upper casts. This visit proved crucial for Indira's back to power in nineteen eighty elections. Rahul or his mother Sonia lacks such vision or karishma. So his Yatra is likely to be futile experiment. But one thing is clear. Only Arvind Kejriwal and Rahul Gandhi are the two leaders are making efforts to take on against PM Modi. Other opposition even Sharad Pawar is not doing anything to give a tussle to Modi or BJP. Rahul seems to be unable to bring opposition together against Modi, but he can at least ignite his party to fight. The Yatra will get success in this context. But there is only danger and that Rahul lacks reliability among his own cadre. Nobody in the party knows that when he leave the country and have a trip to abroad. Even party senior leaders are kept in dark about his foreign trips. So, Congress should worry about Rahul's tantrums. If Rahul show some

sincerity, his party can at least give a

good fight.
