As Intimated earlier, the Company commenced Corporate Insolvency Resolution Process ("CIRP") against Mundara Estate Developers Limited ("MEDL") vide order dated January 12, 2023 passed by the Hon'ble National Company Law Tribunal, Mumbai Bench ("NCLT") under the provisions of the Insolvency and Bankruptcy Code, 2016 ("Code"). Furthermore, in line with the disclosure made to the stock exchange on March 29, 2024, the Committee of Creditors of MEDL ("CoC") has concluded voting on the resolution plan ("Resolution Plan") submitted by Jagjit Estate & Development Company Private Limited, which has been duly approved on March 28, 2024. Subsequently, on April 01, 2024 the Administrator filed an application before the NCLT under Section 30(6) of the Code for the submission of the approved Resolution Plan by the CoC. The application seeking approval of the Resolution Plan is currently pending before the NCLT for adjudication. The final outcome and subsequent adjustments in forthcoming financial periods, is undergoing review. Specifics regarding these financial adjustments will be intimated in due course, in accordance with appropriate disclosure practices.

Subsequently, on April 01, 2024 the Administrator filed an application before the NCLT under Section 30(6) of the Code for the submission of the approved Resolution Plan by the CoC. The application seeking approval of the Resolution Plan is currently pending before the NCLT for adjudication. The final outcome and subsequent adjustments in forthcoming financial periods, is undergoing review. Specifics regarding these financial adjustments will be intimated in due course, in accordance with appropriate disclosure practices.
