I, **CS Sandeep Parekh**, Proprietor of Sandeep P Parekh & Co, Company Secretaries was appointed as the Scrutinizer to conduct the Ballot at the AGM Venue as well as the Remote e-voting process by the Members of the Company pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 for the Resolutions proposed at the 14<sup>th</sup> Annual General Meeting of the members of the Company held on Thursday, 29<sup>th</sup> September, 2022 at 11:00 am at Seth Issardas Varandmal Memorial Dharamshala, Opp. Sindhu Sweets, 3rd Road, Khar (W), Mumbai 400 052

I hereby submit my report as follows:

- a) The Company had availed the remote e-voting facility provided by National Securities Depository Limited (NSDL) for conducting the remote e-voting by the Members of the Company. The remote e-voting commenced from 26<sup>th</sup> September, 2022 (9.00 am (IST)) and was open until 28<sup>th</sup> September, 2022 (5.00 pm (IST)) and the NSDL remote e-voting platform was unblocked thereafter.
- b) The Company has also provided ballot voting facility at the venue of the AGM for the Members who do not have access to/did not cast their votes through remote e-voting.
- c) The members of the Company holding shares as on the "cut-off" date i.e. 22<sup>nd</sup> September, 2022, were entitled to vote on the proposed resolutions as contained in the Notice of the AGM by remote e-voting system prior to AGM and voting at the AGM venue.
- d) I have scrutinized and reviewed the remote e-voting prior and during the AGM and votes cast therein based on the data downloaded from the NSDL e-voting system.
- e) The Management of the Company is responsible to ensure compliance with the requirements of the Act and rules relating to remote e-voting prior and during the AGM on the resolutions contained in the notice of the AGM.
