1. The Explanatory Statements and reasons for the proposed Special Business pursuant to Section 102 read with Section 110 of the Act setting out material facts are appended herein below.
2. For this purpose, the Company has entered into an agreement with Central Depository Services (India) Limited ("CDSL") for facilitating voting through electronic means, as the authorized agency. The procedure for e-voting is explained under the Notes provided with this Postal Ballot Notice.
3. The Board of Directors has appointed Shri Arun Kumar Gupta (FCS No.: F5551) failing which, Shri Aditya Garg (ACS No.: 61863) of M/s Arun Kumar Gupta & Associates (COP No.: 5086), Company Secretaries, Delhi, as the Scrutinizer for conducting the postal ballot only through the e-voting process in a fair and transparent manner and he has communicated his willingness to be appointed for the said purpose.
4. The remote e-voting period commences from **9.00 AM. (IST) on Sunday, November 19, 2023** and ends at **5.00 PM (IST) on Monday, December 18, 2023**.
5. The Postal Ballot Notice is being sent to the Members of the Company whose names appear on the Register of Members/List of Beneficial Owners as received from the Depositories as on **Friday, November 10, 2023, the cut-off date**. The Members, whose names appear in the Register of Members / List of Beneficial Owners as on **Friday, November 10, 2023**, are entitled to vote on the Resolution set forth in this Notice. A person who is not a Member as on the cut-off date should treat this Notice of Postal Ballot for information purpose only.
6. In line with the MCA Circulars, the Postal Ballot Notice is being sent only by electronic mode to those members whose e-mail addresses are registered with the Company/ Depositories. 7. In accordance with the provisions of the MCA Circulars, Shareholders can vote only through the remote e-voting process. 8. Resolution passed by the shareholders through postal ballot is deemed to have been passed as if it has been passed at a General Meeting of the shareholders.

9. The voting rights of Members shall be in proportion to their shares of the paid-up equity share capital of the Company as on **Friday, November 10, 2023**, being the cut-off date fixed for the purpose.
10. In compliance with Sections 108 and 110 of the Act and the rules made there under, the MCA Circulars and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company has provided the facility to the shareholders to exercise their votes electronically on the resolution through the e-voting service facility arranged by Central Depository Services (India) Limited. The instructions for e-voting are provided as part of this Postal Ballot Notice.
11. Shareholders desiring to exercise their vote through the e-voting process are requested to read the instructions in the Notes under the section "General information and instructions relating to e-voting" in this Postal Ballot Notice. The voting period commences on **Sunday, November 19, 2023 at 9.00 AM (IST)** and ends at **5.00 PM (IST) on Monday, December 18, 2023** (both days inclusive). The e-voting module shall be disabled by CDSL for voting thereafter.
12. The Scrutinizer will submit its report to the Chairman after the completion of scrutiny and the result of the voting by postal ballot through the e-voting process will be announced by the Chairman or Company Secretary & Compliance Officer of the Company duly authorised, on or before **Wednesday, December 20, 2023** and will also be displayed on the website of the Company (www.tfcilttd.com), besides being communicated to the Stock Exchange viz. BSE Limited, NSE Limited, Depositories. The Scrutinizer's decision on the validity of e-voting will be final.
13. Pursuant to Regulation 36(3) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and Secretarial Standard on General Meetings issued by the Institute of Company Secretaries of India, the relevant details of Director being appointed are annexed to this notice.
14. The resolution, if passed by the requisite majority, shall be deemed to have been passed on **Monday, December 18, 2023** i.e., the last date specified for receipt of votes through the e-voting process.

17. The General information and instructions for Shareholders for remote e-voting are as under:

CDSL e-Voting System – For Remote e-voting.

- i) The voting period begins on **Sunday, November 19, 2023 at 9.00 am. (IST)** and ends at **5.00 PM (IST) on Monday, December 18, 2023**. During this period shareholders of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date of **Friday, November 10, 2023** may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.
- ii) Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/ CIR/P/2020/242 dated 09.12.2020, under Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository

Participants. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.
