Japan struck by earthquake of 8.5 intensity, one dead

Tokyo : Japan was struck by an earthquake on Friday. The intensity of the earthquake was recorded at 8.5 on the Richter Scale. Preliminary information said that one person died and several images were damaged. The United States Geological Survey stated that tremors were felt in an area spreading over 8.7 kilometers, at 2.42 pm. The epicentre was at 37.540

degrees north and 137.305 degrees east. Strong tremors were felt at Ishikawa prefecture on the Japanese island of Honshu. The buildings near the seashore were shaken. The intensity was earlier recorded at 6.3 and later at 6.5. The intensity at Honshu was recorded at 6.2. Tremors were felt also in Suzu City, where minor damage has been reported. Rescue operations are in progress.

2 drug peddlers arrested, 6 kg of heroin recovered

Jammu : A Police Party of Police Station Poonch, headed by Insp. Ranjeet Singh Rao SHO PS Poonch, were on patrolling/naka duty in Nangali Sahib area. Two persons who were sitting under a Chinar tree near Drungli Bridge Nangali Sahib who after noticing the movement of police party tried to flee away. The prompt and swift action of police party chased them and apprehended them on the spot. During the course of enquiry, they disclosed their names as. During their personal search, Mohd Mashook was carrying a red colour bag, from which 02 packets of Heroin like substance weighing about 02 kg were recovered from his possession. Both the persons were sitting there with common and criminal intention to deliver the said consignment. In this context a Case FIR NO 54/2023 U/S 8/21/22/29 NDPS Act has been registered at PS Poonch and investigation was taken up.

recovered from ward No 01 Panchayat Ghar Mohalla Degwar Maldyalan in the presence of magistrate which were concealed by him beneath the stones. Moreover, on the disclosure of said Mohd Maroof, 01 packet of heroin like substance was recovered in the presence of Magistrate from Ward NO 01 Panchayat Ghar Mohalla Degwar Maldyalan, which was concealed by him in bushes. Hence the total 06 packets of heroin like substance weighing 06 kg got recovered from their possession which have been seized on the spot and the said persons have been arrested in the instant case. Further investigation is going on and more recoveries and arrested can't be ruled out.

The arrest and recovery was made by a Team of PS Poonch headed by Insp. Ranjeet Singh Rao SHO PS Poonch along with the assistance of Indian Army of Durga Battalion under the supervision of Afrat Hussain-JKPS Dy.SP Hqs Poonch, Mushim Ahmed-JKPS Addl.SP Poonch and under the overall supervision of Rohit Baskotra-JKPS SSP Poonch.

District administration demolishes house of militant accused in Reasi

Reasi : District Administration demolished the house of militant accused Mohammad Auraf Sheikh, which was allegedly raised government land, informed the Department of Information and Public Relations. The demolition was conducted in coordination with district police and in the presence of independent witnesses as well as locals in the area. The accused, Auraf, is a resident of Baransal Gulabgarh under Mahore Tehsil and was a teacher at a government school. However, he was terminated from service after his involvement in blasts was established by the

police. He was found involved in explosions triggered in buses at Katra and Narwal in Jammu. According to the DIPR, the blast at Kadmal near Katra was executed by Auraf with sticky IEDs. The explosion left 5 persons dead and 28 injured. The twin IED blasts in Narwal area of Jammu left 9 persons injured. With the arrest of Auraf Sheikh in these cases, J&K Police successfully busted the militant module operating from across the border in Pakistan, read the statement from DIPR. Earlier, too, government land encroached by Auraf was retrieved by the district administration as part of an anti-encroachment drive carried out by the Revenue department.

Locals stage protest against opening of wine shop in Doda

Doda : The residents of Gandoh held a protest demonstration and blocked Gandoh-Jie road against the opening of a wine shop in Dadhar Gandoh near private schools at Sub-District Headquarters Gandoh, here on Friday.

The protestors, especially women residing in Gandoh and Dadhar were chanting slogans against the opening of the wine shop which opened in the residential area. They alleged that the Government is deliberately indulging the youth in drug addiction by opening wine shops in populated areas. It is difficult for women, girls and school going children to pass from the front of the wine shop, which was established near the two private schools, they said. They also alleged that the Government is violating rules and regulations by opening the wine shops in populated areas and near religious and educational places, which is not acceptable.
