## Ref: Our intimation under Reg 30 dated March 17, 2022

Please refer to our letter dated March 17, 2022 filed with you, pursuant to the provisions of Regulation 30 and Regulation 31(8)(d) of SEBI (Listing Obligations & Disclosure Requirement) Regulations, 2015 ("LODR"), intimating that the Company has received approval from the National Stock Exchange of India Limited ("NSE") and BSE Limited ("BSE") for reclassification of the outgoing Promoters and Promoter Group shareholders from Promoter category to public category in accordance with the Regulation 31A (10) of LODR.

However, it was observed that in the letter of NSE, the letter date was mentioned as March 16, 2021 instead of March 16, 2022. Further, in the letter of BSE, the names of two outgoing promoters group entities (i.e. Mahima Advertising LLP and Sumathi Infra Project LLP) had been left out inadvertently. BSE has issued revised approval letter on April 25, 2022 and NSE had issued a corrigendum on same date. Accordingly, we are forwarding copies of the said Letters issued by both NSE and BSE, which may please be taken on record and read with our earlier communication dated March, 17, 2022.
