# Anwarul sworn in as Pak caretaker PM

Anwarul Haq Kakar, an ethnic Pushtun leader who is considered close to the powerful military, was on Monday sworn in as Pakistan's caretaker prime minister to head a neutral political set-up to run the cash-strapped country and conduct the next general elections.

President Arif Alvi administered the oath to 52-year-old Kakar at a simple ceremony held at the President House, attended by outgoing prime minister Shehbaz Sharif and several top leaders. He became the 8th interim prime minister of Pakistan.

Kakar, an ethnic Pushtun from the Balochistan province, was unanimously chosen as interim premier to oversee the elections as provided in the Constitution. He was serving as a senator but resigned from the post after his appointment as prime minister.

The acting premier, a first-time Senator, also resigned from the Balochistan Awami Party (BAP), a party set up in 2018 and deemed

closer to the powerful establishment of the country. After taking the oath, Kakar drove to the PM House, the palatial official residence of prime minister nestled in the foothills of the Margalla mountains, where he was introduced to the new staff.

The immediate task of Kakar is to form a cabinet to assist him run the country. According to insiders, Jalil Abbas Jilani, a former career diplomat, is expected to be appointed as foreign minister. He was also among the runners for the post of interim premier. Kakar now faces the daunting task of holding free and fair elections and keeping the fragile economy on an even keel.

Meanwhile, former premier Sharif left the PM House and was presented a farewell guard of honour by troops from the three services of the country. Kakar's name was agreed upon during the final day of consultations between Prime Minister Sharif and the Leader of the Opposition in the dissolved National Assembly, Raja Riaz Ahmad on Saturday.

Senate Chairman Sadiq Sanjarani on Monday accepted Kakar's resignation from the Senate ahead of the latter's swearing-in as the caretaker prime minister. A day earlier, Kakar announced his resignation from the Senate as well as the Balochistan Awami Party (BAP), which he founded in 2018. According to Geo News,

Kakar stepped down from his post because he wanted to be an impartial interim premier. Since it was his responsibility to hold free and fair general elections in cooperation with the Election Commission of Pakistan, he had decided to resign.

A notification issued by the Senate Secretariat on

Monday notified Kakar's resignation.

"Anwarul Haq Kakar, a member Senate of Pakistan, has resigned his seat, as his principled stance of neutrality on becoming the caretaker prime minister, by writing under his hand in person before the Senate chairman," the notification said.

"The honourable Senate chairman has been pleased to accept the resignation and consequently his seat has become vacant in terms of clause (1) of Article 64 of the Constitution of the Islamic Republic of Pakistan with effect from August 14," it added. In a statement on Sunday, Sharif expressed confidence that Kakar would ensure fair elections. He said the "trust reposed by all parties in Kakar's name proves their proper choice as the upcoming caretaker Prime Minister is an educated person and a patriot".

According to Sharif, Kakar was decided upon under a constitutional process as he was the "most suitable person" to head the interim set-up.

# Hindu man held in Pak for blasphemy

A Hindu man in Pakistan's Punjab province has been arrested for allegedly committing blasphemy by making 'disrespectful' comments about Muslim holy places and shifted to jail to protect him from an enraged mob, police said on Monday.

The police took the suspect - identified as Akbar Ram of West of Rahim Yar Khan district, some 400 kms from provincial capital Lahore - into custody on the complaint filed by Faisal Munir, a person from his area, who produced two witnesses before the police to make a case against him.

Inspector Safdar Hussain of Kotsamaba Police Station Rahim Yar Khan told PTI on Monday that police arrested suspect Akbar Ram under blasphemy charges on August 11 and immediately shifted him to jail on judicial remand fearing a law-and-order situation in the area as he was accused of hurting the sentiments of Muslims," Hussain said.

Akbar Ram has been booked both under blasphemy law (295-A of Pakistan Penal Code) and the Punjab Maintenance of Public Order Ordinance. The official added that the timely arrival of police saved the life of Akbar Ram.

"Police reached the village after learning that a Hindu man

had committed blasphemy and the people were gathering near his house. Police controlled the situation and took Akbar Ram into custody as the mob was demanding that he should be handed over to them," he said. According to the FIR, a copy of which is available with PTI, complainant Faisal Munir, a motor mechanic by profession, said that he was present at his workshop along with Tahiq Majid and Muhammad Tariq when Akbar Ram came there and started making comments disrespectful to Muslim holy places.

The complainant further alleged that Akbar Ram before committing blasphemy in front of many people on August 11 also used to make objectionable comments about Islam before him. The family members of Akbar Ram have reportedly fled the village after blasphemy charges were hurled at him to save their lives. Pakistan is among the countries where blasphemy is punishable by death. Blasphemy is a highly sensitive issue in the country, where even unproven allegations can stir mobs and violence. In 2021, a Sri Lankan national who was working as a factory manager in Punjab province was killed by an angry mob over allegations of blasphemy. Minorities including Christians and Hindus in Pakistan have frequently been subjected to blasphemy allegations and some were tried and even sentenced under the tough blasphemy law.

# Blast in eastern Af hotel kills 3, wounds 7

Islamabad (AP): An explosion ripped through a hotel in Afghanistan's eastern province of Khost on Monday, killing at least three people and wounding seven others, police said.

The blast occurred at a city hotel frequented by Afghan people and refugees from Pakistan's former militant stronghold of North Waziristan, said Mustaghfir Gurbaz, a police spokesperson in Khost.

He said officers were investigating to determine what caused the blast and who was behind it. There was no immediate claim of responsibility, though Afghanistan's Taliban government has blamed the regional affiliate of the Islamic State group - known as the Islamic State in Khurasan Province - for previous attacks.

Gurbaz provided no information about the Pakistani refugees staying at the hotel. Authorities in Pakistan have said members of the Pakistani Taliban, known as Tehreek-e-Taliban Pakistan or TTP, are hiding in Khost and elsewhere in Afghanistan. TTP is a separate group but is a close ally of the Afghan Taliban, which seized power in Afghanistan in August 2021 as US and NATO troops were in the final stages of their pullout from the country after 20 years of war.

Pakistani officials say many TTP leaders and fighters have found sanctuaries in Afghanistan since the Taliban takeover, which also emboldened the Pakistani Taliban.

# Imran appeals Pakistanis to fight for justice

Islamabad (PTI): Pakistan's former prime minister Imran Khan in a pre-recorded video message for the 77th Independence Day said Pakistanis should struggle for justice and equality as only a country which gives importance to justice and merit flourishes. "Pakistan was a dream of Allama Iqbal and Mohammad Ali Jinnah (Pakistan's founder), whose entire struggle was to liberate the Muslims of (undivided) India by establishing a state like Medina whose leaders ruled over the world," said the former prime minister, who is serving a three-year jail term following his conviction in a corruption case.

"They dreamed of such a Pakistan where the most important thing was justice and equality and the law protected the weaker section of the society from the powerful people," the cricketer-turned-politician said, adding that only a society which gives importance to justice flourishes. The Pakistan Tehreek-e-Insaf (PTI) leader said that Pakistanis do not need to look for opportunities in other nations when justice, which encourages merit, prevails in Pakistan. "Merit and justice together will bring prosperity in Pakistan," the 70-year-old leader said, appealing

to Pakistanis to struggle for the betterment of their country. "No matter wherever you go, you won't find a place better than Pakistan. So let's make this country better by struggling together for Pakistan's independence (from the claws of injustice and inequality)," Khan said. He added that the future of Pakistan will be bright only when everyone is treated equally before the law.

Khan is currently lodged in the Attock jail after being convicted in the Toshakhana corruption case. The Election Commission following his conviction barred the politician from participating in political activities for five years.

PTI Core Committee on Monday expressed concerns that Khan could suffer from "slow-poisoning" and demanded that arrangements be made to instantly provide him homemade food and water. The News reported. The PTI also strongly denounced the "unjustifiable delay" in the hearing of the bail application of Khan, who faces several charges of corruption as well as terrorism.

The PTI leaders expressed deep concern over keeping Khan in Attock jail in sheer violation of rules and the unnecessary delay in the decision on the plea to transfer him to Adiala jail.

# Prez calls for unity as Pak celebrates 77th I-Day

Pakistan President Arif Alvi on Monday appealed to politicians to shun their differences and antagonism as the cash-strapped country celebrated its 77th Independence Day amid political and economic turmoil.

Addressing a flag hoisting ceremony held at the Convention Centre here, the president also expressed his gratitude to friendly countries like China, Saudi Arabia, the United Arab Emirates, Iran and Turkiye for supporting Pakistan during its economic woes. He expressed confidence that Pakistan could become a developed country in a few years. Asking politicians and other stakeholders to embrace the path of forgiveness, Alvi said, "My demand to the leaders of this country is to be united." The president said it was

important to break free from nepotism, promote meritocracy, and ensure comprehensive justice, particularly in the socio-economic sphere, in order to progress.

He regretted that 27 million children in Pakistan are out of school and asked the rich of the country to come forward and make arrangements for their education. He also highlighted the greater participation of women in economic activities. Talking about terrorism, he said that about 100,000 people were killed in the fight against the menace and assured that Pakistan was committed to the fight against terrorism.

Separately, in his special message, Alvi urged citizens to work for the welfare and uplift of deprived sections of the society. "It is a time to renew our commitment to building a stronger and more prosperous Pakistan as envisioned by the

Father of the Nation. I urge my fellow countrymen to work for welfare and uplift of deprived sections of our society," he said. The president also reiterated the need for national unity to surmount social, political, economic and security challenges. In his Independence Day message, outgoing Prime Minister Shehbaz Sharif said that while the country had defeated many odds and achieved milestones, "the story of Pakistan has yet to reach its culmination".

He emphasised that unity was one of the most remarkable aspects of Pakistan's independence that emerged from a diverse tapestry of cultures, languages, and ethnicities.

Chief of Army Staff (COAS) Gen Asim Munir paid tribute to the nation's founding fathers and stressed that the country knew how to defend its hard-earned freedom.

# Registrations for Iran polls hit record high

Tehran (AP): A record number of people registered to become candidates in Iran's parliamentary elections scheduled for March, the Interior Ministry said on Monday. The elections will be the first since nationwide protests rocked the country last year. Nearly 49,000 people filed paperwork seeking to run as candidates during a one-week registration period that ended on Sunday, the ministry website said.

That number is more than three times the 16,000 registrations filed in the last election in 2020, when voter turnout was its lowest since 1979, with just over 42 per cent of eligible voters casting ballots. There were no details on the registration of prominent political figures or pro-reform groups. The increase in filings was seen as a result of an easy online registration process. Some 14 per cent of submissions were from women, an increase from 12 per cent in 2020.

# Typhoon approaches western Japan

Tokyo (AP): A powerful typhoon was approaching Japan's main archipelago of Honshu on Monday, threatening to hit large areas of western and central Japan with heavy rain and high winds, as many people were travelling for a Buddhist holiday week.

Typhoon Lan was packing winds of up to 126 kph (78 mph) as it headed northwest over the Pacific Ocean south of Cape Shionomisaki in the central Japanese prefecture of

Wakayama, according to the Japan Meteorological Agency. The typhoon is expected to make landfall on Tuesday morning, cut across the region and veer east toward Hokkaido over waters between Japan and the Korean Peninsula, the JMA said. The typhoon, arriving in the middle of the Bon Buddhist holiday week, is expected to affect many Japanese travelling to visit their families and relatives, as transportation and event opera-

tors in the typhoon's predicted path have decided to suspend services through Tuesday. Central Japan Railway Co. said Shinkansen "bullet" train operations between Nagoya in central Japan and Okayama in western Japan will be suspended, and services between Tokyo and Nagoya will also be largely reduced. Expressways in the region will be also closed, and hundreds of domestic flights will be grounded on Tuesday.
