Sub: Intimation regarding sale of shares of wholly owned subsidiary company

Ltd.(SRMPL) wholly owned subsidiary** at the rate of Rs.27.50 per share, which shall be effective from 1st April, 2023.

Consequently, after transfer of said shares, status of SRMPL as wholly owned subsidiary will be cease, however it will continue to be "subsidiary company" of the Company in terms of provisions of Section 2(87) of the Companies Act, 2013.
