Please refer your email dated 06-11-2019 bearing number L/SURV/ONL/PV/NJ/2019-2020/701 wherein you have reminded our company that our company was required to intimate all the events, information etc. under Regulation 30 of the SEBI (LODR) Regulation, 2015 that have a bearing effect on the performance/operations of the company and which were price sensitive in nature. Further in your above said letter you have advised the company to provide information/announcement (including pending announcements) which are price sensitive in nature.

In this regard, we would like to inform you that Annual General Meeting of the company was held on 26-09-2019, i.e. long back, wherein no announcements were made by the Chairman which could have resulted in rise in price of the shares of the company or could be termed as price sensitive in nature. The fact is that company has been paying dividend @0.50 Paise per equity shares since 2015-2016 and there has been no substantial change in the turnover or profitability in the profits of the company. Hence, these can not be the reasons for sudden increase in the price of shares of our company. Further even there is no substantial change in the book order position of the company. Further the Board of the Company approved declared/published its Unaudited Financial results for the quarter and six months ended on 30<sup>th</sup> September, 2019 and there was no substantial change in the profitability of the company for the quarter and half year ended on 30<sup>th</sup> September, 2019. Hence this can not be the reason for increase/decrease in price of the shares.

We have noted that there is no substantial change in the price and volume of shares of the company since 01<sup>st</sup> October, 2019. We append below the table for the price and number of shares traded as on 01<sup>st</sup> October, 2019 and on 06<sup>th</sup> November, 2019 for your ready reference :-
