

2. Previous period figures have been regressed/rearranged wherever considered necessary.  
3. The figures for the period ended 31-03-2022 are based on the latest audited financials, there is a swift turnaround in the "pipes" segment. The management is seriously contemplating the certainty and sustainability for the above said turnaround in the future, based on future profits projection. Current projections being made hand to hand etc. Pending the above, as matter of prudence, the company has not recognised the said deferred tax asset.  
4. The figures of the quarter ended March 31, 2022 are the balancing figures between audited figures in respect of the previous two quarters and un-audited projected figures for the remaining two quarters up to date figures up to December 31, 2021, being the date of the end of the third quarter of the Financial Year.  
5. Operating Segments: The Company primarily operates in two segments i.e. Pipes & Textiles. The products considered for each operating segments are: 1) Pipes includes HDPE, PVC pipe, irrigation system; 2) Textile including Milk Processing.
