## कोयना जलाशयाशी संबंधित शासकीय गुपिते कायद्यात बदल

कोयना धरण जलाशय परिसरात पर्यटन विकासाचा मार्ग मोकळा मुंबई, दि. १० (प्रतिनिधी) : महाराष्ट्राची भाग्यरेषा म्हणून ओळख असलेले कोयना धरण अर्थात शिवसागरच्या बँकवॉटर परिसरात पर्यटन विकासाला चालना देण्यासाठी शासकीय गुपिते कायदा १९२३ मध्ये अंशतः बदल केला आहे. या सुधारणेमुळे धरण आणि आजूबाजूच्या ७ किमी पर्यतच्या क्षेत्राला प्रतिबंधित क्षेत्र म्हणून अबाधित ठेवून उर्वरित जलाशयाचा ८० किमीचा परिसर पर्यटनदृष्ट्या विकसित करण्याचा मार्ग मोकळा झाला आहे. या निर्णयामुळे सातारा जिल्हा जल पर्यटनात मोठी झेप घेऊ शकेल, असा विश्वास मुख्यमंत्री एकनाथ शिंदे यांनी व्यक्त केला आहे.

मुख्यमंत्री शिंदे म्हणाले की, या निर्णयानुसार धरण क्षेत्राच्या सुरक्षिततेला प्राधान्य देत धरण आणि आजूबाजूच्या ७ किमी पर्यतच्या क्षेत्राला प्रतिबंधित क्षेत्र म्हणून अबाधित ठेवले आहे. तसेच ७ किमी नंतरच्या २ किमी च्या क्षेत्राला बफर झोन म्हणून घोषित केले आहे.

त्यापलीकडील जलाशयाचा विस्तीर्ण परिसर जल पर्यटनाच्या दृष्टीने विकसित करण्यात येणार आहे. यात महाराष्ट्र पर्यटन विकास महामंडळाच्या माध्यमातून जावळी तालुक्यातील मुनावळे येथे जागतिक दर्जाचे जल पर्यटन विकसित करण्याचे शासनाचे नियोजन आहे. त्यासाठी तब्बल ४७ कोटीचा निधी मंजूर करण्यात आला आहे.

सातारा येथील शिवसागर अर्थात कोयना धरण येथील जंगले, सद्दाप्री डोंगराच्या रांगा, निळेशार पाणी असे निसर्गाचे वरदान लाभलेले आहे. शिवसागर जलाशयात जल पर्यटन विकसित करण्यासाठी मोठी संधी आहे. या शिवसागर धरणामध्ये जल पर्यटन विकसित झाल्यास महाबळेश्वर, पांचगणी, वाई, कास पठार येथे येणारा पर्यटक शिवसागर जलाशयाकडे वळविता येईल.

या माध्यमातून सातारा जिल्हासाठी पर्यटकांची नवीन बाजारपेठ निर्माण होऊ शकणार आहे.
