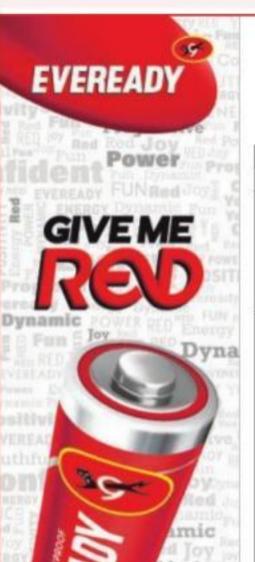
1. The above financial results have been reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on February 13, 2020. The statutory auditors have carried out a limited review of the results for the guarter and nine months ended December 31, 2019.

2. The adoption of Ind AS 116 - Leases, effective April 1, 2019, did not have a material impact on the financial results of the company for the quarter and nine months ended December 31, 2019. 3. The Company operates in one primary segment only, i.e., Opthalmics Lenses and therefore Indian Accounting Standard ('Ind AS') 108 Operating Segment is not applicable.

4. The Company has issued 750,000 convertible equity warrants on preferential basis on July 27, 2018, at an issue price of Rs 155/- per warrant. On January 22, 2020, the Company allotted 400,000 equity shares to the warrant holders who exercised the option for conversion of the warrants into equity shares and paid the balance 75% allotment money of Rs 465.00 lakhs. With respect to the remaining holders of 350,000 convertible equity warrants who have not exercised the option for conversion, the Company has forfeited the 25% upfront amount of Rs 135.63 lakhs, earlier received.

केंद्र सरकारने संसदेत मांडलेला केंद्रीय अर्थसंकल्प २०२०-२१ हा निराशाजनक आहे. सर्वसामान्यांसाठी या अर्थसंकल्पात कसलीच तरतूद केली नसून तो जनविरोधी असल्याची टीका करुन त्याचा निषेध करण्यासाठी पणजी येथील आझाद मैदानावर आयटक गोवातर्फे शक्रवारी निदर्शने करण्यात आली. केंद्रीय अर्थसंकल्प जनविरोधीत आहे, तर मुख्यमंत्री डॉ. प्रमोद सावंत यांनी मांडलेला गोवा राज्याचा अर्थसंकल्प हा अर्थहीन असल्याची टीका आयटकचे सचिव अड. राजू मगराकर पाना कला. सरचिटणीस

आयटकचे खिस्तोफर फोन्सेका म्हणाले, की केंद्र सरकारने संसदेत मांडलेल्या अर्थसंकल्पात रोजगारवृध्दी तसेच महागाईवर नियंत्रण ठेवण्यासाठी कसलीच तरतद करण्यात आलेली नाही, देशात आज रोजगाराचा प्रश्न गंभीर बनला आहे. मात्र, नव्या रोजगारसंधी तयार करण्यासाठी तसेच रोजगारभिमुख उद्योगाला चालना देण्यासाठी सरकारकडून या अर्थसंक्र्रल्पात कसलीच पावले आलेली नाहीत. उचलण्यात

करण्ययासंदर्भात देखील कसलाच उल्लेख करण्यात आलेला नाही.

देशाच्या अर्थव्यवस्थेत कृषी क्षेत्राचा महत्त्वाचा वाटा आहे. मात्र. कृषी क्षेत्राला चालना देण्यासाठी गृंतवणुकीसंदर्भात आवश्यक तितकी तरतूद करण्यात आलेली नाही. एका बाजूने शेतकरी आत्महत्या करीत आहेत तर दुसऱ्या बाजूने सरकारला त्याची जाण नाही. २०१४ सालापासून केंद्रीय अर्थसंकल्पात शेतकऱ्यांसाठी तसेच कृषी क्षेत्रासाठी फार कमी तरतूद केली जात आहे.
