Mahindra Auto registers 65% growth in SUVs with sales of 27380 vehicles in March 2022

Mumbai, April 1, 2022: Mahindra & Mahindra Ltd. (M&M Ltd.), one of India's leading automotive companies, today announced that its overall auto sales for the month of March 2022 stood at **54643** vehicles.

In the Utility Vehicles segment, Mahindra sold **27380** vehicles in March 2022. The Passenger Vehicles segment (which includes UVs, Cars and Vans) sold **27603** vehicles in March 2022. Exports for the month were at **3160** vehicles.

In the Commercial Vehicles segment, Mahindra sold **19837** vehicles in March 2022 with growth of **16%**. All the Light Commercial Vehicle Segments of <2T, Pickups (2T to 3.5T), >3.5T and the heavy commercial vehicles continued their growth trajectory in March 2022.

Mahindra's Farm Equipment Sector Sells 28112 Units in India during March 2022

Mumbai, April 1, 2022: Mahindra & Mahindra Ltd.'s Farm Equipment Sector (FES), part of the Mahindra Group, today announced its tractor sales numbers for March 2022.

Domestic sales in March 2022 were at 28112 units, as against 29817 units during March 2021.

Total tractor sales (Domestic + Exports) during March 2022 were at **29763** units, as against **30970** units for the same period last year.

Exports for the month stood at 1651 units.

Commenting on the performance, Hemant Sikka, President - Farm Equipment Sector, Mahindra & Mahindra Ltd. said, "We have sold 28112 tractors in the domestic market during March 2022. Record procurement of Kharif acreage, substantial increase in exports of agricultural products like wheat, sugar and cotton will help improve the financial position of the farmers leading to better cash flow in the rural market to help boost tractor demand going forward. Acreage of kharif crop has already crossed last year's levels, which augurs well for agri incomes. This will get a further boost with early forecast of a normal monsoon. In the exports market, we have sold 1651 tractors, a growth of 43% over last year."
