Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with Para A of Part A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015 read with SEBI circular dated July 13, 2023, and other applicable regulations, if any, we hereby inform that the Company has received an order dated December 22, 2023 (“the Order”) in the name of L&T Housing Finance Limited (which was earlier merged with L&T Finance Limited (“LTF”) and LTF has been merged with the Company effective December 4, 2023), whereby the Department of Goods & Services Tax, Government of Gujarat, has imposed a monetary penalty of Rs. 49,682 under Section 73 of the Central Goods and Services Tax Act, 2017.

The Company is contesting the Order in appellate forums and the Company does not reasonably expect the Order to have any material financial impact.
