दिल्ली नगर निगम चुनाव के करीब ढाई महीने बाद बुधवार को महापौर का चुनाव हुआ। इस चुनाव में आम आदमी पार्टी की शैली ओबेराय ने भारतीय जनता पार्टी की रेखा गुप्ता को हरा दिया। 'आप' ने नतीजों को दिल्लीवासियों की जीत करार दिया है। शैली ने गुप्ता को 34 मतों के अंतर से हराया। उपमहापौर चुनाव में 'आप' के आले मोहम्मद इकबाल को 147 मत मिले, वहीं भाजपा के कमल बागड़ी को 116 मत मिले। इकबाल ने 31 मतों के अंतर से बागड़ी को परास्त कर दिया।

निर्वाचक मंडल में निर्वाचित पाषण्डों के 250 वोट, भाजपा के सात लोकसभा सदस्य और दिल्ली से आप के तीन राज्यसभा सदस्य और 14 विधायकों के वोट शामिल थे। विधायकों में आप के 13 और भाजपा के एक विधायक के वोट थे। एमसीडी सदन में कांग्रेस के नौ पाषण्ड हैं। चुनाव परिणाम घोषित करते हुए पीठासीन अधिकारी और भाजपा पाषण्ड सत्या शर्मा ने मतदान प्रक्रिया से अनुपस्थित रहने वाले आठ पाषण्डों के नामों की घोषणा की। ये सभी पाषण्ड कांग्रेस के थे।

विवि में अनुशासनहीनता सहन नहीं : कुलपति

चुनाव में संख्या बल आम आदमी पार्टी के पक्ष में था। कुल 274 मतों में से भाजपा के 113 मतों के मुकाबले 'आप' को 150 मत मिले। दो मत निर्दलीय पाषण्डों के थे। शैली को उनकी पार्टी के हिसाब से सभी मत मिले। जबकि भाजपा को तीन मत अधिक मिले। दिल्लीवासियों को बधाई देते हुए केजरीवाल ने ट्वीट किया, 'गुंडे हार गए, जनता जीत गई। दिल्ली नगर निगम में आज दिल्ली की जनता की जीत हुई और गुंडागर्दी की हार।

नतीजे घोषित होने के तुरंत बाद आप पाषण्डों ने नवनिर्वाचित महापौर को मिटाई खिलाई जबकि महिला पाषण्डों को उनके साथ सेल्फी लेने के लिए मंच पर धक्का-मुक्की करते देखा गया। निर्वाचित होने के बाद शैली ओबेराय ने कहा, 'मैं मुख्यमंत्री अरविंद केजरीवाल, मनीष सिंसोदिया और दिल्ली के लोगों को धन्यवाद देती हूँ। अगले तीन दिन में हम यहाँ कचरा पट्टी का निरीक्षण करेंगे।' उन्होंने कहा, 'सभी पाषण्ड आज से काम करेंगे। दस-गारंटी कार्यक्रम पर हमारा ध्यान रहेगा। मैं न्यायपालिका का भी शुक्रिया अदा करना चाहती हूँ।' उपमुख्यमंत्री मनीष सिंसोदिया ने भी जीत पर शैली ओबेराय और पार्टी कार्यकर्ताओं को बधाई दी।

कांग्रेस ने पूर्व में घोषणा की थी कि उसके सभी नौ पाषण्ड मतदान से दूर रहेंगे। इससे पहले दिन में हुए मतदान में हो सकता है कि कांग्रेस के एक पाषण्ड ने भाजपा को वोट दिया हो, लेकिन न तो पार्टी की ओर से और न ही एमसीडी सचिवालय की ओर से आधिकारिक पुष्टि हुई। कांग्रेस की दिल्ली इकाई के प्रमुख अनिल चौधरी ने कहा कि उन्हें पता चला है कि पार्टी के एक पाषण्ड ने मतदान में भाग लिया था, वे उनकी पहचान करने की कोशिश कर रहे हैं।
