As per the Agreement, SIL has, inter alia, agreed to subscribe 8,69,030 (Eight Lakh Sixty Nine Thousand and Thirty) Class B Equity Shares of Rs.10/- each of SML (Approx. 2% of the present share capital of SML), subject to the necessary approval(s) as required for issue and allotment of the Class B Equity Shares. These Class B Equity Shares will be partly paid up initially and will become fully paid up over a period of 3 years as per the agreed schedule.

On successful performance by SIL and SS of their obligations and upon the achievement of the milestones and delivery of the deliverables and upon issue of further Class B Equity Shares as agreed between SML and SIL & SS, the final stake of SIL in SML may result in ownership of Class B Equity Shares of upto approx. 5% of the present paid-up share capital of SML.

Consequently, SML shall cease to be a wholly-owned subsidiary of the Company but will continue to be a subsidiary company,
