I, Shirin Bhatt, Practicing Company Secretary (Membership No. F8273/ C.P. No. 9150) appointed as Scrutinizer by the Board of Directors of the Company vide resolution dated September 26<sup>th</sup>, 2023 for the purpose of scrutinising and ascertaining the requisite majority of the votes cast in the Postal Ballot conducted via remote e-voting (the "**Postal Ballot**") held between **09.00 AM on Tuesday October 3<sup>rd</sup>, 2023 and ended on IST 05.00 PM on Wednesday November 1<sup>st</sup>, 2023**, being undertaken under Section 108 and 110 of the Companies Act, 2013 read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 and relevant MCA Circulars, on the resolutions contained in the **Postal Ballot Notice** of the Company dated **September, 23<sup>rd</sup> 2023**.

# We submit our report as under:

- **1.** The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013, Rules thereunder read with relevant MCA Circulars, Secretarial Standards on General Meetings (SS-2) and regulations contained in the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 relating to voting through electronic means on the resolutions contained in the Postal Ballot Notice.
- **2.** The responsibility as a scrutiniser for the remote e-voting is restricted to the extent of preparation and presentation of Scrutiniser's Report of the votes cast "FOR" or "AGAINST" on the resolutions stated in the Notice, based on the reports generated from the e-voting systems provided by the NSDL at https://www.evoting.nsdl.com/ the authorized agency to provide e-voting facilities.

- 4.
