Delayed submission and Non-submission of Returns: Levy of Penalty


Please refer to the Show-cause Notice issued to the company vide letter No. NHB (ND)/DoS/DMC/OUT07297/2020 dated December 01, 2020 and subsequent communications in the matter.

2. Based on the examination of the issue including the submission made by the company, the National Housing Bank has decided to levy a penalty of ₹16,000 (Rupees Sixteen Thousand Only) for delayed and non-Submission of various returns.
