In continuation of our earlier letters dated 24<sup>th</sup> October, 2019 and 25<sup>th</sup> October, 2019, regarding the admission of petition by the National Company Law Tribunal ("NCLT"), Mumbai Bench, vide order dated 22<sup>nd</sup> October 2019, filed by one of the Operational creditors, M/s. Scorpion Express Private Limited ("Scorpion"), we wish to inform you that Mr. Indrajit Mukherjee having registration No. IBBI/IPA-001/IP-P-01533/2018-2019/12450 has been appointed as the Interim Resolution Professional ('IRP') in the matter.

It has been informed to the IRP regarding the agreement of settlement entered into between the Company and Scorpion on 25<sup>th</sup> October, 2019. However, the IRP was appointed before Scorpion could make an application to NCLT for withdrawal of its application.
