This is in furtherance of our letter dated 21st July, 2023, we are in receipt of your mail dated July 17, 2023 with respect to the above-mentioned subject, in which a fine of Rs. 41,300/- (including GST) was levied against non-compliance with regard to Regulation 23(9) of SEBI (Listing Obligations and Disclosure Requirement) Regulations, 2015 (“**Listing Regulations**”), regarding the delayed filing for Related Party Transaction (“**RPT**”) in XBRL Mode for the half-year ended on March 31, 2023.

In furtherance to SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020 it is informed that Yasho industries Limited (the Company) have transferred the fine of Rs. 41,300/- in the bank account mentioned in the email dated July 17, 2023 on 28th July, 2023 vide UTR No: R001232091537671.
