Over 6,000 teachers appointed in Delhi govt-run schools due to LG's 'proactive approach': LG office

NEW DELHI, JAN 31 /--/ Over 6,000 teachers have been appointed in schools run by the Delhi government in the last four months due to the "proactive approach" of Lieutenant Governor (LG) VK Saxena, his office said on Tuesday. The Lieutenant Governor's office in a statement also said that another 2,200 appointments will be done by March. "Under nudge from LG (lieutenant governor), 6,112 new teachers appointed in Delhi government schools in just four

months another 2,200 will be appointed by March," Saxena's office claimed in the statement. There was no immediate response from the Arvind Kejriwal government to the claims. "Non-requisition on part of the education department to the DSSSB (Delhi Subordinate Services Selection Board) had led to huge vacancies amounting to 24,003 teachers," the statement said. "The proactive approach and constant nudging from Lt Governor VK Saxena has resulted in filling up the vacancies of teachers, principals, vice principals in Delhi government schools at an unprecedented pace during the last four months," his office claimed in the statement. Since September 16 last year, when the LG first reviewed the status of vacancies in the education department, a "whopping 6,112 vacant posts of teachers have been filled by the DSSSB through regular

recruitment", it said. The statement said that another 2,200 vacancies of teachers in the schools will be filled by March. Saxena has since then chaired three meetings of officers and the DSSSB to ensure regular monitoring of the progress made, his office said. The statement said that according to data provided by the DSSSB, at a review meeting chaired by the LG, the total vacancies of teaching staff in Delhi government schools that stood at "a massive 24,003 on September 16 last year, has come down to 17,891". "In the process, the number of guest teachers has proportionately come down by 3,094. As on 16.09.2022, the number of guest teachers stood at 19,880 while the same has been reduced to 16,786 as on 31.01.2023," the LG office said. During the review meeting, officials informed the LG that the requirement for filling 543 vacant posts of principals -- 363 through direct recruitment and 180 through promotion -- has been sent to the Union Public Service Commission (UPSC) and the interviews are likely to be completed by March 2023, the statement said. Seatsharing with Tipra Motha likely in Tripura: CPI-M

AGARTALA, JAN 31 /--/ Tripura CPI(M) secretary Jitendra Choudhury Tuesday said Tipra Motha, a tribal regional party, has resumed dialogues with the Left party for likely seat adjustment by the two parties to defeat BJP in the February 16 Assembly poll. Choudhury said that Tipra Motha supremo Pradyot Kishore Manikya Debbarma had telephoned him on Tuesday morning and said that the party has not named any contestant at Sabroom, from where he is contesting.

The Left party leader claimed that Debbarma has assured that he will undertake an assessment of winnability of the candidates to take on BJP and CPI-M and Tipra Motha will support each other wherever either of them are relatively weak. "The Tipra Motha chief said he will let me know by this evening... Even if the matter is not yet finalised today, I believe it

will be settled by February 2, the last date of withdrawal of nomination," Choudhury claimed.

All political parties in the northeast state - BJP, CPI(M) and Congress had reached out to Tipra Motha supremo Pradyot Kishore Manikya Debbarma for an electoral understanding.

However, no tie up has been finalised as yet due to Tipra Motha's rigid stand on Greater Tripaland. The regional party has already fielded candidates in 40 constituencies of the 60-member House. The CPI-M leader said that the Left Front's seat sharing with Congress, which ran into rough weather, will also be settled shortly. Names of 47 Left Front candidates were declared on January 25 and 13 seats were left for Congress.

The Congress leadership had, however, expressed dissatisfaction with the arrangement and fielded candidates in 16 Assembly constituencies. This has created a deadlock over seat sharing deal between the two parties.

"We have entered into a seat sharing deal with the Left Front to defeat BJP. It is not an alliance. It should be understood by others," Congress MLA Sudip Roy Barman had said on Monday. (PTI)

Mizoram govt to take measures to seal godowns storing smuggled areca nuts

AIZAWL, JAN 31 /--/The Mizoram government would take measures to seal all godowns illegally run to store smuggled areca nuts, an official statement said on Monday. A meeting of a task group on illegal areca nuts chaired by home commissioner and secretary H Lalengmawia on Monday decided that the task group would submit its report to the Central Customs department to ensure that all illegal godowns along with stored smuggled areca nuts in different parts of the state are sealed and necessary legal action is taken accordingly, it said. The meeting decided to continue collection of ex-

isting stocks of smuggled areca nuts from across the state during February, the statement said. The meeting also decided to intensify measures to curb smuggling of areca nuts from Myanmar and other south east Asian countries. The meeting further decided that state police would strengthen all checkpoints across the state to make them function purposefully and volunteers of Young Mizo Association (YMA) would assist them in all possible ways to control smuggling activities. Deputy commissioners would also submit detailed Land Settlement Certificates (LSCs) or village council

passes of land owners where areca nut godowns are being set up, the meeting said. The task group on illegal areca nuts was formed in December last year to curb smuggling of areca nuts from Myanmar and other south east Asian countries.

East Mizoram's Champhai district has become a conduit of smuggling for various contrabands, including dried areca nuts, drugs, and exotic animals from Myanmar. Mizoram shares a 510-km long porous border with Myanmar. Local areca nut growers alleged that their markets had been affected by smuggled areca nuts. (PTI)

Maharashtra: Former driver, man held for robbing 70-year-old Mumbai woman

MUMBAI, JAN 31 /--/ The city police on Tuesday arrested two men on the charge of robbing jewellery worth about Rs 12 lakh from a 70-year-old Dadar woman, said an official.

Deputy Commissioner of Police (Zone 5) Manoj Patil identified the two as Kisan Ramchandra Bhawad (52) and Santosh Bhagoji Kadav (55). "Accused Kadav used to work as a driver with the victim's family and it is

suspected that he is the mastermind," said Patil. The woman lives with her husband in a building near Kirti College. On Monday afternoon, she was alone as her husband had gone out, said the DCP. Accused Bhawad knocked on their door and said he had brought sweets from a person named Raikar. When the woman opened the door, he barged in and grabbed her neck. "He then pointed a fake gun at her

and forced the woman to give him her ornaments," said the official, adding that the two fled in a car. After receiving a complaint, the police went through the footage of several CCTV cameras and tracked down the duo to Navi Mumbai, said the official. Bhawad has a criminal past, he said. Both have been booked under the Indian Penal Code and Arms Act, said the official. (PTI)
